Dear Mr. Jordan:

This letter constitutes the response of the Michigan Democratic State Central Committee (MDSCC) and Roger Winkelman to the above complaint.

The complaint has no merit because it is based on an error in reporting, which was promptly corrected once discovered. In the 30 Day Post Election Report referred to in paragraph 7 of the Complaint, the MDSCC erroneously reported on Schedule F two \$45,000 expenditures coordinated with Byrum for Congress. Both expenditures related to Debbie Stabenow for Senate, not Byrum for Congress. A corrected Schedule F, a copy of which is attached, was filed recently.

The MDSCC did not violate the coordinated spending limitations of 2 U.S.C. § 441a(d), given that the two expenditures complained of were not for Byrum for Congress, as reflected in the amended report. The MDSCC is not required to be completely error-free in its reporting. 2 U.S.C. § 432(i); 11 CFR § 104.7(a). Once the inadvertent reporting error was detected, it was promptly corrected.

Because the complaint is premised on erroneous facts, it should be dismissed.
