Dear General Counsel Noble:

I am writing to formally complain about obvious failures on the part of *Dear 2000, Inc.* to fully disclose campaign expenditures as required by law.

On at least six occasions full page advertisements appeared in the *Jewish Press* that carried the disclosure: "Paid for by Dear 2000, Inc.". Enclosed you will find reduced photocopies of some of them as well as a full page original for your reference. According to the rate card (also attached) provided by the newspaper, each of these ads is sold for \$6,600.

At no time did the Dear campaign report these expenditures.

Please investigate these improprieties and inform me of the results.

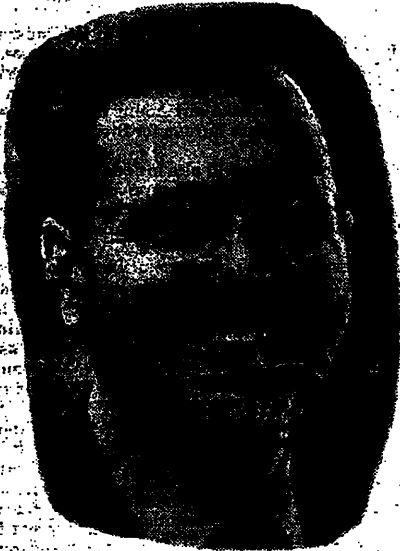
