Dear Chairman McDonald:

After a thorough review of the Reports and Disbursement filings of several national party committees, the National Taxpayers Union believes that two Congressionally-chartered corporations, the Federal Home Loan Mortgage Corporation (Freddie Mac) and the Federal National Mortgage Association (Fannie Mae), have made contributions to the nonfederal accounts of several of these committees in violation of 2 U.S.C. § 441b(a).

As you know, Section 441b of the Federal Election Campaign Act makes it unlawful for any national bank, or any corporation organized by authority of any law of Congress, to make a contribution or expenditure in connection with any election to any political office. Federal regulation makes it clear that the Section 441b prohibition also covers state and local political activity, including "soft money" donations. 11 C.F.R. 114.2(a) states that "national banks and corporations organized by authority of any law of Congress are prohibited from making a contribution . . . in connection with any political office, including local, state and federal offices." It is NTU's understanding that one of the few exceptions to this prohibition is found in 2 U.S.C. 431(8)(B)(viii) which permits corporations, including Congressionally-chartered corporations, to make donations for the construction or purchase of a building by a political party.

As Congressionally-chartered corporations, Fannie Mae and Freddie Mac are strictly prohibited from making contributions to the nonfederal accounts of national party committees which are used to influence federal, state, or local elections. However, from our review, it appears that the corporations made several such contributions, in apparent violation of federal law.

For your review, we are enclosing a 1997-2000 summary report of soft money donations to nonfederal accounts. While some of these contributions may have been made to permissible "building fund" accounts, Fannie Mae's non-building soft money donations totaled almost \$340,000 and Freddie Mac's non-building soft money donations totaled slightly in excess of \$400,000. These nonfederal accounts are routinely the source of funds transferred to state party funds which are in turn used for the expressed advocacy of state and local candidates in addition to registration and get-out-the-vote efforts which are candidate-specific. Fannie Mae and Freddie Mac are specifically

prohibited from using resources to impact on such state and local election-related activities.

Further, we request that you examine the building fund contributions (in excess of \$1 million by Fannie Mae and in excess of \$2.4 million by Freddie Mac) to ensure that these funds were not diverted to prohibited nonfederal accounts. The law is very specific that such contributions may be used only for "construction or purchase of any office facility" and not to fund the political campaigns of state and local officials or other election-related activities.




