GENERAL COUNSEL'S REPORT 2

I. ACTIONS RECOMMENDED:

Accept the attached conciliation agreement with the Oakland Democratic Campaign Committee, David Woodward, Treasurer.

II. BACKGROUND

This case originated as a RAD referral, and pre-dates the inception of the Administrative Fines program. On April 30, 2001, the Commission found reason to believe that the respondents violated the Act by failing to file and filing late certain campaign reports required during 1999 and 2000, and by operating without a treasurer, and by failing to keep a current address on file with the Commission. 2 U.S.C. § 434(a)(4)(A)(i), (iv), 433(c), 432(a). On that same date, the Commission authorized pre-probable cause conciliation.

Attached is a conciliation agreement which has been signed by Gary L. Kohut, Chair of the Oakland Democratic Campaign Committee.
