
I have been authorized by my client to sign the tolling document which you forwarded to me. You will find the executed copy of said document enclosed herewith.





**CONSENT TO EXTEND THE TIME
TO INSTITUTE A CIVIL LAW ENFORCEMENT SUIT**

As consideration for the Federal Election Commission's agreement to extend the period for the production of documents and written answers under a Subpoena and Order issued in this matter, Respondents Kentucky State District Council of Carpenters, and Steve Barger, as treasurer, and Steve Barger, Don Mitchell, and Thomas Schulz, individually, hereby consent to toll the statute of limitations for any civil enforcement action that the Federal Election Commission might institute in connection with MUR 5268 pursuant to 2 U.S.C. § 437g(a)(6) from June 12, 2002 through April 25, 2003. This action will extend the time to institute a civil law enforcement pertaining to any violation in this matter for which the statute of limitations had not already run on June 12, 2002, for three-hundred and seventeen (317) days from the expiration date of the five-year statute of limitations found at 28 U.S.C. § 2462, or any other statute of limitations or repose that may be applicable, in these matters.
