
Dear Ann Marie:

CARPENTERS & JOINERS OF AMERICA CHARTER



Acting
Under
the
Constitution and Laws of the
United Brotherhood of Carpenters and Joiners of America
and designated as the
Indiana/Kentucky Regional Council
to be held by those who are in part of their affiliation with the
United Brotherhood of Carpenters and Joiners of America, and of their
subordination to the Constitution and Laws.

It is further agreed that the
aforesaid Council shall conform to the Constitution and Laws of the
United Brotherhood of Carpenters and Joiners of America, and in the
event thereof this charter may be revoked and the Council suspended from all
rights, privileges and benefits of the organization.

It is further agreed that should the aforesaid Council, without
cause, be suspended or forfeit this charter, then all property, money, tools
and papers shall become the property of the
United Brotherhood of Carpenters and Joiners of America, and shall be
forwarded forthwith to the Grand Secretary of the aforesaid organization in
Washington, D.C.

In consideration of the due and faithful performance of the foregoing conditions
the United Brotherhood of Carpenters and Joiners of America, hereby
binds itself to maintain and defend the **Indiana/Kentucky
Regional Council** in the exercise of all rights, privileges
and benefits as a subordinate Council under its jurisdiction.

In Witness Whereof, we solemnly and mutually
bind and offer the seal of the United Brotherhood
of Carpenters and Joiners of America, and
its Grand Secretary, to the following effect:
