The aforementioned individuals have received their notifications at different times and all have considered their choices of legal counsel prior to arranging for the services of this firm. Now that each of these individuals has chosen to retain this firm, we will be meeting with each individual respondent separately to explain the Commission process and the legal theory on which the "reason to believe" notification is based. We will also be spending time with each client reviewing the information requested by the Commission, which we expect will take a great deal of time.

Because August is a vacation month and Clive S. Cummis, Esq., the chief counsel handling this matter, has recently undergone emergency surgery and has been in and out of the hospital for the better part of the last few weeks, we do not anticipate being able to meet with each client prior to the end of August. Moreover, because each of the above-listed respondents is an observant Orthodox Jew, the month of September presents some scheduling conflicts in that Rosh Hashanah, Yom Kippur, Sukkot, Shemini Atzerth and Simchat Torah all occur during the month of September. The Commission should further be advised that both Mr. Cummis and the undersigned are also of the Jewish faith and will be observing many of the above-listed holidays during the month of September. Finally, the undersigned will be on an extended absence from the office from October 2, 2002 through October 19, 2002.

For all of these reasons, we request an extension of time until September 30, 2002, to respond on behalf of our clients. Although we anticipate being able to respond to the Commission's request by this time, we reserve the right to request a further extension if we find that vacation schedules, Mr. Cummis' injury, the Jewish holidays and my extend absence pose difficulties in our ability to thoroughly respond on behalf of our clients.




