I am responding to your request that the Commission provide documentation supporting the Commission's reason to believe findings that respondents Barbara Gellert, George Gellert, Dara Kushner, Jared Kushner, Rae Kushner, Linda Laulicht, Pamela Laulicht and Melvin Scheinerman violated 2 U.S.C. §441a(a)(3) by exceeding their annual contribution limitations.

A listing of the contributions used to calculate the amount of the violations is attached for the individual respondents. You will notice that in some instances we have revised the amount of total contributions because contributions to unauthorized committees in non-election years were erroneously included. Furthermore, as documented in the contribution chart, it appears that this particular violation is no longer relevant with regard to respondent Rae Kushner.
