Pursuant to paragraph VIII of the Conciliation Agreement effective June 20, 2003 in the above-referenced matter, the Michigan Republican State Committee (MRSC) is required to transfer \$276,826 from the MRSC Federal Account to certain MRSC Non-Federal Accounts (\$31,459 to the MRSC State Account and \$245,367 to the MRSC Administrative Account) by no later than August 20, 2004. On April 28, 2004, the last of these transfers were made.

Attached please find a spreadsheet of these transfers. All transferred amounts have been reported to the Federal Election Commission by the MRSC on its monthly campaign finance reports, so the contents of the attached transfer schedule can be readily identified by the Federal Election Commission. Now that these transfers have occurred, the MRSC has performed all of its obligations pursuant to the above-referenced Conciliation Agreement.
