This is in response to the Commission's letter dated November 1, 2002, enclosing a complaint filed against Team Majority. A designation of counsel is enclosed.

Team Majority is a nonconnected political committee established to support democratic candidates around the country. It initially registered in April 2002, and qualified as a multi-candidate committee in September 2002. Political allies of Congresswoman Nancy Pelosi established the PAC and sought her support and participation in its activities, including, in particular, her assistance with fundraising.

It is this connection with Mrs. Pelosi that apparently drew the attention of Complainant, as she has also been involved and assisted with fundraising for another nonconnected PAC, PAC to the Future. Team Majority has chosen not to contest the politically motivated concerns expressed in public, but rather, to avoid any question about its activities, or the activities of PAC to the Future, has taken the following steps to suspend its operations:

- The PAC refunded all contributions from donors who had also given to PAC to the Future, which, when aggregated, would have exceeded \$5,000. Copies of these refund checks are attached as Exhibit A.
- The PAC has sought refunds from each candidate who received a contribution from both Team Majority and PAC to the Future which, when aggregated, exceeded \$5,000. Copies of those refund checks received to date are attached as Exhibit B.
