Dear Ms. Smith:

Enclosed is a copy of the letter forwarded to our office by the Federal Election Commission on January 27, 2003. As you will note, this letter is dated November 21, 2002 and addressed to Mr. Charles Kadish. The address, however, is incomplete inasmuch as no street number is included. As a result, Charles Kadish never received this letter.

As previously advised, we represent Charles Kadish in connection with the above-referenced matter. A Statement of Designation of Counsel confirming such was forwarded under cover of the letter of John M. Donnelly, Esq., of my office, dated January 7, 2003. Presumably, this is why the November 21, 2002 letter has been forwarded to my office.

In the January 7, 2003 letter, Mr. Donnelly further advised that, although Charles Kadish had not previously been formally notified of the complaint filed with the Federal Election Commission or his opportunity to respond to same in writing, his response would nevertheless be included with the responses submitted on behalf of Lawrence and Susan Kadish. Subsequently, on January 16, 2003, I forwarded to your attention, via Federal Express, affidavits sworn to by Lawrence Kadish, Susan Kadish and Charles Kadish in response to the complaint. A fourth affidavit, sworn to by Bernard Baval, also was included.

At your earliest convenience, please advise whether a further response is required of Charles Kadish. Otherwise, we will assume that no further response is required at this time.


