3. Enter into conciliation with Rod Grams for U.S. Senate and Christine Grams, as Treasurer, prior to a finding of probable cause to believe.
4. Find reason to believe that David Weiner made an excessive contribution to Rod Grams for U.S. Senate in violation of 2 U.S.C. § 441a(a)(1)(A), but take no further action.
5. Find reason to believe that the Republicans House-District 6B, and John Kuriger, as Treasurer; 41st Senate District Republicans, and Thomas Hulting as Treasurer; Freeborn County Republicans, and James Munyer, as Treasurer; Olmsted County Republicans, and Daniel Thornton, as Treasurer; Redwood County Republicans, and Roald Haugan, as Treasurer; and Waseca County Republicans, and John Wilkus, as Treasurer, violated 2 U.S.C. §§ 431(4)(c) and 434 by failing to register and report, but take no further action.
6. Approve the Conciliation Agreement to Rod Grams for U.S. Senate and Christine Grams, as Treasurer, as recommended in the General Counsel Report dated April 22, 2003.
7. Approve the Factual and Legal Analysis to Rod Grams for U.S. Senate and Christine Grams, as Treasurer, as recommended in the General Counsel's Report dated April 22, 2003.
