Dear Mr. Jordan :

This responds on behalf of our client, Congressman Darrell Issa, to the complaint filed against him in the above referenced matter. Mr. Issa is not seeking federal office in 2004. He is, however, seeking of the Governorship of California in 2003 through that State's unique recall and election process. Accordingly, for the reasons set forth below, Mr. Issa's activities fall within the exception to the nonfederal funds ban stated in 2 USC § 441i(e)(2) and 11 CFR § 300.63. Accordingly, the Federal Election Commission ("Commission") must dismiss the complaint and take no further action.

The complaint constitutes an attempt by the supporters of California Governor Gray Davis to save an extremely unpopular Governor from the humility of being recalled. It seeks, through harassment, to halt a funding source for the state law effort against the Governor by a candidate to replace him. The Commission should not permit political opponents in state and local elections to use the enforcement process to limit the clear right articulated in the statute that federal officeholders seeking election to state office may operate under state law.

Mr. Issa is not a candidate for federal office in the 2004 elections. He has not filed a Form 2, *Statement of Candidacy*, with the Commission or the California papers necessary to gain a position on the ballot for federal office from California. Rather, he is a candidate only for Governor of California. (See Exhibit A.)

Mr. Issa's candidacy is part of a unique procedure under California law that governs, at the same time and the same day and the same election, both the recall of the sitting of the Governor and the selection of a new Governor if the recall receives the majority of votes. Under California law,

opponents of Governor Davis must gather a specified number of signatures to qualify a recall election. See Cal Elec. Code § 11020. Once qualified, a recall election is held in which California voters both vote on (1) whether Governor Davis should be removed from office, and (2) if the recall receives the majority of votes, the next Governor¹. See id. §§ 11320 & 11322. If a majority of the voters elect to recall Governor Davis, the gubernatorial candidate receiving the highest number of votes is elected Governor. See id. §§ 11384 & 11385. No federal candidates will appear on the ballot if, as Mr. Issa and recall supporters seek, the recall election qualifies for the ballot and the election is held this fall.

There is no limit under California law on the amount an individual, corporation or labor union may contribute to Rescue California, a group supporting the recall effort. See Cal. Gov. Code §§ 81000 et seq. Rescue California is registered and reporting with California Fair Political Practices Commission in compliance with California campaign finance law. See Complaint at 2-3.

Mr. Issa's activities in support of the recall petition effort and his candidacy for Governor of California are simultaneous and permissible under 2 USC § 441(e)(2) and 11 CFR § 300.63. The petition process for qualifying the recall election is a legal requirement to holding a new election for California Governor and, therefore, part and parcel, under California law, of Mr. Issa's candidacy for Governor. As such, the recall petition drive that is the subject of the complaint is analogous to an additional petition requirement for a gubernatorial candidate to gain access to the election ballot.

The complaint does not allege, nor can it, that any moneys spent by Rescue California were used to support any federal candidate or to finance any federal election activities. Rather, Rescue California's efforts, and Mr. Issa's activities, have focused exclusively on state political and election matters related to qualifying a recall election of Governor Davis and Mr. Issa's candidacy to replace him. Accordingly, Mr. Issa's activities and financial support of Rescue California are in connection with his candidacy for state office and permissible under 2 USC § 441(e)(2) and 11 CFR § 300.63.

¹ Candidates for Governor for the recall election must gather a specified number of signatures and pay a filing fee in order to gain access to the recall ballot as a gubernatorial candidate See Cal Elec Code §§ 11000 et seq
