This is in response to your letter dated July 28, 2003 requesting that the Federal Election Commission remove any reference to Kleiner Perkins from its First General Counsel's Report regarding Bush-Cheney 2000, Inc. ("the Committee").

You had suggested that Kleiner Perkins did not have any involvement in procuring air travel for the Committee during the 2000 election cycle. You will find enclosed memoranda indicating that the Committee paid Kleiner Perkins for flights at the first class rate rather than the charter rate. If you wish to pursue this matter further, please explain this apparent discrepancy at your earliest convenience.

If I do not receive a response from you within 10 days, I will assume that Kleiner Perkins no longer wishes to pursue this matter, and the Commission's Report will be released to the public.
