Factual History:

In the 2002 election cycle, Kevin Garn and Rob Bishop were two candidates participating in the Republican primary seeking an opportunity to be the Republican candidate in the general election for Utah's First Congressional District. Rob Bishop was strongly supported by the Utah League of Credit Unions and its member credit unions, which was never more evident than in the two weeks prior to the June 25th primary election. Beginning on the 14th and continuing through the 24th of June, member credit unions mounted an intense and comprehensive campaign effort encouraging their respective members to vote for Rob Bishop. Upon information and belief, the campaign efforts included, but were not necessarily limited to, the following:

- 1) Four full color, two-sided 8.5" x 5.5" flyer mailings to all credit union account holders in the First Congressional District (there was no cross-referencing of lists so members with more than one account at one institution or those with accounts at more than one institution received multiple mailings) (exemplars attached - Tab A);
- 2) One newsletter mailing from the Utah League of Credit Unions (exemplar attached - Tab B);
- 3) Recorded phone messages delivered to each credit union member by the CEO of the respective credit union(s) to which they belong;
- 4) Credit unions conducted telephone polling of members during which roughly one half of the questions were questions specifically directed to the choice between banks and credit unions with the goal of engendering support for Rob Bishop (e.g. "Would you be more likely to support a school teacher or a bank president?");
- 5) Credit unions had employees canvass neighborhoods in the First Congressional District during regular work hours requesting votes for Rob Bishop;
- 6) On February 3, 2002, Rob Bishop loaned his campaign committee \$5,000 of his personal funds, on March 3, 2002, Rob Bishop loaned his campaign committee \$3,000 of his personal funds, and on March 12, 2002, Rob Bishop loaned his campaign committee \$15,000 of his personal funds (see FEC Schedule C forms filed by Rob Bishop - Tab C);
- 7) On June 18, 2002, seven days before the June 25th primary, Rob Bishop obtained a signature loan in the amount of \$40,000.00 from America First Credit Union which he immediately loaned to his campaign. Rob Bishop did not have the financial assets to justify such a loan, nor any apparent means to repay the loan.

Allegations:

Under-Reporting and/or Failure to Report Communication Expenditures:

11 CFR 114.3(a)(2) provides that incorporated cooperatives may make communications to their restricted class, or any part of that class,¹ on any subject, including express advocacy (11 CFR 114.3(a)(1)), through printed publications produced at their expense (11 CFR 114.3(c)(1)) and through the use of phone banks urging the restricted class to register and/or vote for a particular candidate (11 CFR 114.3(3)). 11CFR 100.8(b)(4) requires that any cost incurred for any communication by a membership organization to its members which expressly advocates the election or defeat of a clearly identified candidate shall be reported to the FEC on FEC Form 7 if those costs exceed \$2,000 per election.

Each of the credit union Respondents filed an FEC Form 7, Report of Communication Costs by Corporations and Membership Organizations, as required by 11 CFR 104.6 with respect to the subject primary election. All communication expenditures reported by the eight reporting Respondents were made in support of Rob Bishop in Utah's First Congressional District primary election. The member credit unions that did report, reported as follows:

America First Credit Union: 6/14/02 - 6/21/02 - \$39,071.87 for direct mailings to members (see attached - Tab D);

USU Community Credit Union: 6/14/02 - 6/24/02 - \$7,283.56 for direct mailings to members (see attached - Tab D);

Mountain America Credit Union: 6/14/02 - 6/24/02 - \$6,427.26 for direct mailings to members except 6/24 the expenditure was for phone solicitation to members (see attached - Tab D);

Tooele Federal Credit Union: 6/14/02 - 6/21/02 - \$4,658.19 for direct mailings to members (see attached - Tab D);

Deseret First Credit Union: 6/14/02 - 6/24/02 - \$4,665.48 for direct mailings to

members except 6/20 the expenditure was for phone solicitation to members (see attached - Tab D);

Goldenwest Credit Union: 6/14/02 - 6/21/02 - \$3,146.56 for direct mailings to members (see attached - Tab D);

Horizon Credit Union: 6/14/02 - 6/21/02 - \$3,026.76 for direct mailings to members (see attached - Tab D);

Box Elder County Credit Union: 6/14/02 - 6/21/02 - \$2,067.76 for direct mailings to members (see attached - Tab D).

The total reported by all credit unions for Rob Bishop support efforts in the First Congressional District primary is \$70,347.44. However, the total reportable expenditures for the support efforts is, upon information and belief, believed to be at least \$164,000.00 and very likely, a much higher number.

The Utah League of Credit Unions claims there are 1.2 million credit union members in Utah. It is unclear how many of these members reside in the Utah's First Congressional District, although it is believed that this district has a higher percentage than any other congressional district in the country. In any event, for ease of calculation, one can assume that roughly one-third, or 400,000 credit union members, reside in the district. Thus, upon information and belief, Respondent credit unions spent an estimated \$128,000 on direct mailings (4 mailings at an estimated \$16,000 per mailing for printing costs and \$16,000 per mailing for postage costs), as well as an estimated \$36,000 on phone bank calls (calls to 400,000 members at an estimated \$.09 per call). This amounts to under-reporting of approximately \$93,650 in violation of 11 CFR 100.8(b)(4), without taking into account any multiple mailings that resulted from the failure to cross-reference membership lists.

In addition, upon information and belief, Respondent credit unions conducted telephone polling of credit union members and roughly half of the questions were aimed at issues of banks versus credit unions. Also, upon information and belief, Respondents had employees use work time to walk door-to-door in First Congressional District neighborhoods expressly advocating votes for Rob Bishop. If the visits were limited to members of the credit union the employee worked for, they were reportable pursuant to 11 CFR 104.6 once the costs of the polling and employee time exceeded \$2,000. No such costs were reported by any of the Respondent credit unions. If they were general door-to-door visits, the expenses related to these activities may qualify as a reportable in-kind contribution pursuant to 11 CFR 100.7(a)(1)(iii). If so, such contributions were not reported by the Rob Bishop for Congress committee.

Utah League of Credit Union Newsletter was Improper:

The Utah League of Credit Unions ("ULCU") is a "political committee" within the meaning of 11 CFR 100.5(a). The ULCU circulates a periodic newsletter called *Credit Union Advocate* which according the tag line, is "[p]ublished for the benefit of Utah's 1.2 Million Credit Union Members." The Summer 2002 edition (Tab A) expressly advocates that recipients vote for Rob Bishop in June 25, 2002 primary election.² The lead article provides biographical information on Rob Bishop and directly compares him to his primary opponent, Kevin Garn. The final paragraph expressly requests that recipients vote for Rob Bishop. Moreover, a large letter banner appears at the bottom of the first page which also expressly advocates that recipients vote for Rob Bishop and the same message appears on the back page under the "Inside This Issue . . ." heading.

11 CFR 114.1(e)(5) dictates that when an organization has a federation structure or has affiliates at several levels, such as a state level, a person who qualifies as a member of one affiliate qualifies as a member of all affiliates within that organization if the affiliation determination factors set forth in 11 CFR 100.5(g)(2), (3) and (4) are satisfied. Here, it is unclear if those affiliation factors can be satisfied such that all members of credit unions which belong to the ULCU can be considered members of the League and the other member credit unions. Regardless, the 2002 Summer newsletter was improper.³

If the affiliation factors can be satisfied, the ULCU can communicate with the members of all member credit unions just as those member credit unions can communicate with their respective members. Specifically, as noted above, 11 CFR 114.3(a)(2) provides that incorporated cooperatives may make communications to their members on any subject, including express advocacy (11 CFR 114.3(a)(1)), through printed publications produced at their expense (11 CFR 114.3(c)(1)) and through the use of phone banks urging the restricted class to register and/or vote for a particular candidate (11 CFR 114.3(3)). 11CFR 100.8(b)(4) requires that any cost incurred for any communication by a membership organization to its members which expressly advocates the election or defeat of a clearly identified candidate shall be reported to the FEC on FEC Form 7 if those costs

³If the communication was a coordinated general public political communication within the meaning of 11 CFR 109.1(b)(4) and 100 23, it is subject to the expenditure limitations of 11 CFR 110 7. It would also be an expenditure within the meaning of 11 CFR 100 8(a) and an in-kind contribution within the meaning of 11 CFR 100 7(a)(1)(3) which, in turn, means that contribution prohibitions and/or limits and reporting requirements must be observed. As such, if the newsletter qualifies as a coordinated general public political communication, the ULCU failed to observe these requirements.

exceed \$2,000 per election. The ULCU did not file an FEC Form 7 for communication costs related to the primary election but upon information and belief, the costs incurred for the newspaper mailing alone exceeded the reporting threshold of \$2,000 (printing costs alone for 1.2 million newsletters is estimated to be \$31,800, but the cost of postage must be considered as well).

If the affiliate factors cannot be satisfied, the mailing of the Summer 2002 newsletter is an "independent expenditure" for communications to the general public.⁴ As such, 11 CFR 110.11(a)(1) requires that it include a disclaimer meeting the requirements of 11 CFR 102.14(c) and 11 CFR 110.11(5), which it did not include. If the Summer 2002 newsletter was authorized by Rob Bishop, the disclaimer notice also had to meet the requirements of 11 CFR 110.11(a)(1)(ii). If it was not authorized by Rob Bishop, the disclaimer notice had to meet the requirements of 11 CFR 110.11(a)(1)(iii). Since it had no disclaimer whatsoever, obviously these requirements were not met.

Signature Line of Credit from America First Credit Union to Rob Bishop was Improper:

America First Credit Union is a corporation which is prohibited from using its general treasury funds to make contributions or expenditures in connection with federal elections. 2 U.S.C. §441b(a). However, in reality it has done just that. On June 18, 2002, seven days before the June 25th primary, Rob Bishop obtained a signature line of credit in the amount of \$40,000.00 from America First Credit Union. It is unclear whether that line of credit was secured and if so, what form of security was provided. On the same day, Rob Bishop loaned the entire \$40,000 to his campaign. The loan by Rob Bishop to his campaign was not endorsed or guaranteed by anyone, nor was there any real estate, personal property, goods, negotiable instruments, certificates of deposit or other traditional collateral pledged, or any future contributions or future receipts on income pledged as collateral for the loan.

This "shell game" loan should be governed by 11 CFR 100.7. 11 CFR 100.7(b)(11) dictates that such a loan is not a "contribution" to Rob Bishop if it is made in accordance with applicable banking laws and regulations and is made in the ordinary course of business. A loan is deemed to be made in the ordinary course of business if it bears the usual and customary interest rate of the lending institution for the category of the loan involved, is made on a basis which assures repayment, is evidenced by a written instrument, and is subject to a due date or amortization schedule. A loan, including a line of credit, is considered to be made on a basis which assures repayment if it is obtained using one of two sources of repayment. The first is the lending institution making the loan has a perfected security interest in collateral owned by the candidate or political committee receiving the loan (11 CFR 100.7(b)(11)(i)(A)(1)), and the second is that the lending institution making the

loan has obtained a written agreement whereby the candidate or political committee receiving the loan has pledged future receipts as collateral (11 CFR 100.7(b)(11)(i)(B)).

The forms filed by Rob Bishop which evidence the \$40,000 loan funded by America First Credit Union and extended to his campaign committee do not meet the criteria established for "made on a basis which assures repayment." However, 11 CFR 100.7(b)(11)(ii) provides that if the requirements of 11 CFR 100.7(b)(11)(i) cannot be met, the Commission will consider the totality of circumstances on a case-by-case basis to determine whether the loan was made on a basis which assures repayment.

In this case, the determination cannot be made that the \$40,000 America First Credit Union line of credit, all of which Rob Bishop immediately turned over to his campaign committee, was made on a basis that assured repayment. Rob Bishop was a teacher employed by the Box Elder School District and a part time lobbyist. He reported 2001 income between \$91,927 and 92,726. This includes his \$43,700 teaching salary and \$40,000 in income from lobbying. He listed assets between \$51,002 and \$115,000 (not counting personal homes or cars) and liabilities of between \$15,001 and \$50,000. He disclosed his net worth as between \$1,000 and \$100,000. Also, prior to America First Credit Union extending him the \$40,000 line of credit, he had already loaned \$23,000 of his net worth to his campaign. It simply cannot be argued that the \$40,000 line of credit, which amounts to more than one-third of the high end of his stated net worth before he loaned the \$23,000 to his campaign, was made on any basis which assured repayment.


Conclusion and Relief Requested:

The foregoing readily demonstrates that Respondents have committed various violations of the rules and procedures of the Federal Election Commission. These violations include under-reporting of reportable expenditures, complete failure to report reportable expenditures, utilizing improper forms of communications and making improper loans. As such, Complainant respectfully requests that the Federal Election Commission pursue all remedies available to it pursuant 11 CFR 111 for the established violations.

Calvin Bird is running for his first term in the State House of Representatives. The district includes Spanish Fork, Mapleton, and Springville.

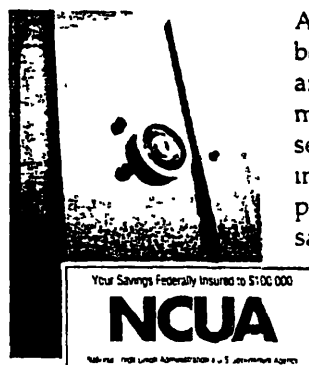

All credit unions are strong because you, our member-owners, are in control. You demand good member service. For the 17th consecutive time, consumers responding to the American Banker newspaper's consumer satisfaction poll say they're most satisfied with credit unions.

You demand favorable rates and fees. Credit unions remain the low-cost, high-return providers of products and services.

Consumer Are Growing Over Increase Size Number of Bank Fees

Who could blame average bank customers today if they feel nicked and dined -- and dollared -- by their bank?

There is a fee when an account drops below its minimum balance, a \$20-plus fee for bouncing a check, fees for overdraft protection and, at some banks, a fee for using a debit card to get cash back at the grocery.

Bank fees have gone through the roof, and that's put many consumers in a snit.

Banks say they have no choice. Nonbank competitors have been chewing away at their traditional money-making products -- loans -- and they need to make up the revenue.



For decades, bank fees have been growing in number and size because of their growing importance to the bottom line. Fee income represented 43 percent of net operating revenue at the nation's banks in 2000, more than twice the 18 percent it represented in 1976, according to the Federal Deposit Insurance Corp.

In 2001, fee income at commercial banks totaled \$157.2 billion.

Although they are the subject of a significant amount of attention -- and outrage -- only about 17 percent of the fees come from service charges to deposit accounts, with the bulk coming from credit cards and corporate services.

Much of the discontent comes from customers who suddenly must pay fees for services that used to be free.

Banks do a dance with consumers to determine how much they can charge without losing profitable customers. But sometimes the motivation is more complex. Often, the fees are charged to customers who are deemed unprofitable or expendable. Sometimes they are imposed strategically, to encourage customers to behave in ways that benefit the bank, such as using ATMs instead of tellers. •

Credit Union Members Enjoy Low Fees

Bank Rank Monitor reports that bank lawyers are turning up in courtrooms a lot these days, "as consumers fight bank transaction fees through class-action lawsuits."

Credit union members have a much more effective way of influencing fees and other charges—as member-owners, you keep fees down simply by using credit union services. The more services you use, the more cost effective all services become. And credit union fees are low to begin with, because credit unions are not-for-profit cooperatives that return income to members in the form of lower fees and loan rates and higher savings rates.

Just how bad is it getting? Here are some examples:

- The Florida Public Interest Research Group estimates it could cost nonbank customers at one institution as much as \$14 to \$25 just to cash a government check or a private check drawn on another institution.
- Nationally, more than 12 million people without checking accounts are using check-cashing stores instead, to the tune of an average \$162 a year per person, according to a U.S. Public Interest Research Group (U.S. PIRG) study.

- Bounced check fees drew a lawsuit for Wells Fargo Bank, based in California. Say a customer has \$95 in a checking account, but writes checks for \$30, \$25, \$20 and \$100 for a total of \$175. Bank Rate Monitor reports, "A bank that pays the smallest check first would clear the first three checks before bouncing the fourth and largest check. The customer would pay one bounced-check fee. But a bank that pays the largest check first would charge the customer fees for four bounced checks."



You and other consumers can keep fees manageable by using your accounts appropriately and by using credit union services. Call your credit union about service packages that reduce our low fees even more. You're the reason we're here, and we can help you hold the line on fees. •


