Dear Mr. Holman:

This is in reference to the complaint you filed with the Federal Election Commission on October 16, 2003, concerning Epiphany Productions, Inc. and Robert Mitchell Delk. The Commission found that there was reason to believe Epiphany Productions, Inc., the Federal Home Loan Mortgage Corporation ("Freddie Mac"), SER Corp. d/b/a Galileo Restaurant, Leland Brendsel, Clarke Camper, Robert Mitchell Delk, the Republican National Committee ("RNC"), and the Republican Governors Association ("RGA") violated 2 U.S.C. § 441b, a provision of the Federal Election Campaign Act of 1971, as amended, and conducted an investigation in this matter. On April 17, 2006, a conciliation agreement signed by Freddie Mac was accepted by the Commission. The Commission took no further action as to violations of 2 U.S.C. § 441b by Epiphany Productions, Inc., SER Corp. d/b/a Galileo Restaurant, Leland Brendsel, Clarke Camper, Robert Mitchell Delk, the RNC, and the RGA, but sent admonishments to Mr. Brendsel, Mr. Camper, Mr. Delk, and Epiphany Productions, Inc. In addition, the Commission found no reason to believe Robert Mitchell Delk or Amanda Delk violated 2 U.S.C. § 434(b) and dismissed the allegations that Robert Mitchell Delk and Amanda Delk violated 2 U.S.C. § 441a(a). Accordingly, the Commission closed the file in this matter.

Documents related to the case will be placed on the public record within 30 days. *See* Statement of Policy Regarding Disclosure of Closed Enforcement and Related Files, 68 Fed. Reg. 70,426 (Dec. 18, 2003). A copy of the agreement with Freddie Mac is enclosed for your information. In addition, a copy of the dispositive General Counsel's Reports regarding all the respondents is enclosed.


