Dear Ms. Hart.

Thank you for the time that you and Mr. Sidney Rocke took to discuss the circumstances surrounding MUR 5396 between the Commission and Bauer for President, 2000 (BFP2000). The purpose of this letter is to provide you with the additional information you requested at that meeting with respect to income received by BFP2000 derived from the commercial rental of its contributor mailing list, and the use of the BFP2000 contributor mailing list by Campaign for Working Families (CWF) political action committee (please see the accompanying attachment).

Specifically, the BFP2000 list has currently generated income in the amount of \$171,612.89 since May 1, 2001, and continues to be actively marketed. This total of \$171,612.89 is net of commissions withheld by the list broker.

Also, attached as Exhibit 1 is a chart reflecting 25 additional mailings by CWF of the BFP 2000 mailing list subsequent to April 1, 2001 (and not reflected in the Commission's Factual and Legal Analysis of MUR 5396) by The total number of names represented in these mailings is 27,926.

In addition, as you may recall, we discussed the possibility of BFP2000 obtaining an estimate of value for the BFP2000 contributor mailing list. As yet, BFP2000 continues to attempt to determine this information and will submit this data as soon as it is acquired.


Even without this information, however, BFP2000 hopes that the Commission will give proper consideration to an increased value of the list, as demonstrated both by the income the list continues to generate, and by the ongoing use of the list by CWF.
