Dear Ms. Stevenson:

This responds on behalf of our client, MIKE PAC, to the letter from the Federal Election Commission ("Commission") notifying it of a complaint filed in the above referenced matter. Because MIKE PAC has not contributed to the Geoff Davis for Congress Committee ("Davis Campaign") during the 2004 election cycle, the Commission must dismiss the complaint and take no further action. A Statement of Designation of Counsel is attached. (See Exhibit A.)

The complaint alleges that Quentin Nesbitt made contributions to six political action committees that, in turn, made contributions to Davis Campaign within days of receiving the contributions. The alleged result is that Mr. Nesbitt made excessive contributions to the Davis Campaign totaling \$15,000 through these political action committees.

On September 23, 2003, MIKE PAC received a \$1,000 contribution from Mr. Nesbitt. (See Exhibit B.) The contribution was made by personal check and MIKE PAC sent Mr. Nesbitt a thank you note for his support. (See Exhibit C.) Neither the contribution check nor the thank you note earmarked or otherwise designated the contribution for a specific candidate. Moreover, MIKE PAC has not made any contributions to the Davis Campaign during the 2004 election cycle.
