The Morse for Congress 2004 Committee is responding here to the  
complaint filed by Mr. Shaevel on behalf of the Barney Frank for  
Congress Committee.

**A. CONTRIBUTIONS**

The Morse Committee filed Schedule A (FEC Form 3) listing itemized  
receipts of \$200 and over in writing and by mail with the Federal  
Elections Commission. We were unable to file this portion of the filing  
electronically due to the fact that we couldn't figure out how to access  
these particular documents online. We were, however, successful in  
completing the primary filing documents online. We contend that this  
electronic filing, along with the written and mailed portion, constitutes  
compliance with the filing requirements.

The Frank Committee is rightfully insisting on viewing all Schedule A  
documents filed by the Morse Committee and we are making them  
available to the Frank Committee, their representative, Mr. Shaevel, and  
the FEC along with this letter.

**B. EXPENDITURES**

1. The claim by the Frank Committee that the Boston Globe charged the campaign \$11,529.00 to publish a column is inaccurate. The column was not ¼ of a page and the cost was \$4,542.42. We have enclosed a copy of the cancelled check here. Mr. Morse covered the balance of the amount, \$1,542.42 out of personal funds.
2. The Morse Committee filed Schedule B (FEC Form 3) listing itemized disbursements in writing and by mail with the Federal Elections Commission. As in the case of Schedule A., we were unable to file this portion of the filing electronically due to the fact that we couldn't figure out how to access these particular documents online.

The Frank Committee is again rightfully insisting on viewing all Schedule B documents filed by the Morse Committee and we are making them available to the Frank Committee, their representative, Mr. Shaevel, and the FEC along with this letter.

The Morse Committee is working to achieve compliance with the regulations of the FEC and the candidate fully supports the concept of full disclosure of campaign finances. Please feel free to contact us with further questions.
