My name is E. Kirk Shelmerdine. I am 46 years of age and a resident of Davidson County, North Carolina.

E. KIRK SHELMERDINE, first being duly sworn, deposes and says: ...

I am the sole owner of Kirk Shelmerdine Racing, LLC. This limited liability corporation was formed in the year 2002 and is treated as a sole proprietorship by the IRS as I did not elect to be treated as a corporation.

During the year 2004, I have entered race cars in the NASCAR Nextel Cup Series. The cars are personally driven by me. I am considered to be a "field filler" as my race cars and race team are under funded and have no realistic chance of winning a race. In fact, the race cars are not able to qualify and participate in every race.

The race car was entered in the race at New Hampshire International Speedway conducted September 19, 2004. There were rumors and reports that President George W. Bush would attend and/or be present at some point in time during the race. I put the decals that are the subject of this complaint on the car solely because I thought that doing so would bring attention to the car and publicity for me and the car. It was not my intention, in any manner, to be a supporter of President Bush or to influence the Presidential election.

I am not a registered voter. I have never been actively involved in politics. I have not publicly endorsed or aided any politician. I have never contributed any money or considerations of any kind to any politician, Political Action Committee, etc.

The decals that were placed on the car would cost and have a value of \$50.00 or less.

I repeat that I put the decals on the car to bring attention to myself and my race car. The placing of the decals was in no way in concert or cooperation with Bush-Cheney 2004, Inc., or any persons or organizations that support President George W. Bush.

Prior to receiving the complaint and request for response from the Federal Election Commission, I had no knowledge of any of the laws, rules and regulations that affect contributions to politicians. Based upon the limited amount of knowledge I have acquired, I do not believe that I have violated any of those

laws, rules or regulations. If I have violated same, it was purely unintentional and due to my lack of knowledge.

Out of an abundance of caution, I have removed the decals in question from my race car and do not intend to use them any more.
