Please find enclosed the Statements of Designation of Counsel executed by Mr. William Vanderbrook, Treasurer of the David Vitter for US Senate committee ("Vitter Committee") and Sandra McDade, President/CEO of McRei, Inc., ("McRei"), (collectively hereafter "Respondents") authorizing the undersigned and this Firm to represent Respondents in the above-referenced Matter Under Review ("MUR 5587").

Respondents have forwarded to the Firm your letter together with the Complaint initiating the MUR which alleges that Respondents have violated the Federal Election Campaign Act of 1971, as amended ("the Act"). Your letter and the Complaint against McRei were received by this office on November 11, 2004. The Complaint against the Vitter Committee was not received until yesterday. I was traveling and out of the office until yesterday and have been unable to review the Complaint until then. It appears from the sequence of dates that Respondents are due to file their written responses on or before November 23, 2004.

Respondent McRei has advised me that your office has verbally approved an extension of time for submitting its formal written response to the Complaint. Similarly, Respondent Vitter for US Senate Committee also requests an extension of time to respond. We would request thirty (30) days from today or until December 19, 2004 to file the responses.
