Your letter regarding the above referenced matter was received by my client on November 10, 2004. My client, InfoCision Management Corporation, has designated Steve Brubaker, Vice President of Corporate Affairs, as its internal contact regarding this matter and my law firm as legal counsel. The Statement of Designation of Counsel to this effect is attached hereto as **Exhibit A**. As Gary L. Taylor is not alleged to have been involved in any matter of relevance to this complaint personally, please remove his name and substitute Steve Brubaker's.

My client at all times operates in compliance with applicable law, its contracts with its clients, and the highest standards of business accountability. My client is a member in good standing with the Better Business Bureau and The Direct Marketing Association, and has never been found to have violated any state or federal law regarding its fundraising activities.

Mr. Rusk was called in 2001 as part of a fundraising campaign for the National Republican Congressional Committee. At the time, Congressman Tom Davis was the chairperson of the NRCC, and as such his name was used, with his permission and approval, in this fundraising campaign.

At no time did my client or the NRCC misrepresent their status or any fact relevant to this fundraising activity.

On Thursday, November 18, 2004, I spoke with Kim Stevenson regarding this matter and confirmed that this inquiry concerned possible violation of 2 USCS § 441h regarding fraudulent

misrepresentation of campaign authority. At no time has my client fraudulently misrepresented that it was acting for Congressman Davis in any capacity other than his chairmanship of the NRCC or any other matter.

Please let me know if your concerns include other statutory sections. My client would welcome the opportunity to meet with you to provide you additional information if necessary.

My client has added Mr. Rusk to its internal "do-not-call" list and the NRCC's "do-not-call" list so that he will not be contacted again by this organization or my client.
