This office represents Representative Scott McInnis, Friends of Scott McInnis, Inc. and its treasurer, Mr. C. Dennis King, in the above-captioned matter. Enclosed please find executed Designation of Counsel forms from our clients confirming our retention.

On December 3, 2004, our clients received your November 30, 2004, letter notifying them of the complaint filed against them. Accordingly, a response demonstrating that no action should be taken against our clients is due December 18, 2004. I respectfully request an extension of time to respond to the complaint.
