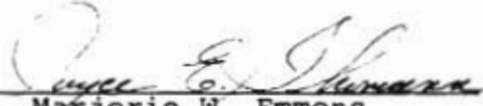

GENERAL COUNSEL'S REPORT

Background

On April 4, 1978, the Disclosure Division referred to the Office of the General Counsel the names of thirteen Senate candidates and committees who had failed to file their 1977 year-end reports with the Federal Election Commission. For each of the thirteen candidates and committees the Commission found reason to believe and reasonable cause to

believe that 2 U.S.C. §434 had been violated. Attempts were made to notify each respondent of the Commission's findings.

Analysis

Four of the thirteen respondents have filed reports with the Commission. The Don Bartlett for U. S. Senate Committee and Terry Miller's Alaska 1st Committee filed 1977 year-end reports subsequent to the Disclosure Division's referral. On May 20, 1978, the Committee to Elect Shannon filed a 1976 year end report which the Committee designated as a termination report. The Genral Counsel's Office discovered that on February 21, 1977, Andrew G. Watson filed a 3a postcard with an accompanying letter which stated that for 1976 Mr. Watson's combined receipts and expenditures totaled less than \$1,000 with no outstanding debts and obligations. When a staff member spoke with Mr. Watson, he indicated that he had intended to terminate his candidacy and that he thought the Commission had accepted his termination.

A summary of the reports filed by the four respondents follows:

As these respondents have filed appropriate reports, it is recommended that no further action be taken.

Of the remaining nine respondents, four are respondents in MUR 574(78) for failure to file several reports required by the Act. They are: Gifford for U. S. Senate, Thurman Jerome Hamlin President '80, Governor '79, U. S. Senate '78, Trenton H. Parker Senate Campaign Committee, Inc., and, Howard L. (Chips) Gifford. As they are multiple nonfilers, compliance action against them was consolidated and continued through MUR 574(78).

Of the remaining two respondents, the Erwin for Senate Committee filed a first quarter postcard for 1977 on May 24, 1977 but has filed no further reports. The Committee did not receive either the RTB or RCTB notifications. Moreover, there is no Erwin, nor Alan K. Short (Treasurer), listed in Ann Arbor, Michigan.

In its 1976 year end report this Committee listed receipts of \$928, expenditures of \$697 and \$985.30 in debts and obligations. Ms. Erwin ran on the Libertarian Party for Senate in Michigan. She received 8,842 votes out of 3,490,664 in the General Election. As neither the candidate nor committee treasurer can be located, as the Committee had minimal activity in 1976, and as the candidate received only .27% of the votes cast it is recommended that no further action be taken.

The final committee, Austin for Senate, filed a year end 1976 report on February 2, 1977, covering the

period August 10, 1976 through December 31, 1976. On this report the Committee listed receipts of \$75,524.16, expenditures of \$76,750.80, and debts/obligations of \$8,297.18. Another report, covering January 1, 1977 through January 31, 1977, was filed on October 21, 1977. On this report the Committee listed receipts of \$11,597.31, expenditures of \$11,597.31, and no debts/obligations. In addition the termination report block was checked. However, this report is not acceptable as a termination report, and the Committee cannot be considered terminated, because the Committee does not account for the large amount of previously reported outstanding debts/obligations.

A request for additional information, explaining the issue involved, was sent to the Committee. The Treasurer of Austin for Senate, Mr. Lawrence Davidson, was also contacted by telephone and informed of the desired corrections. He agreed to file the forms at the end of the April 10, 1978 reporting period. When no report was received by the Commission, Mr. Davidson was again contacted. He thought the reports had been sent, agreed to check on the matter and send in the amendments. As again no reports were received by the Commission Mr. Davidson was called a final time on July 27, 1977. He explained the problem of the Committee's

unreported debts/obligations in the following manner: The Committee owed money for advertising expenses, accounting expenses and taxes. However, as all the contracted advertisements were not used, the amount owed was diminished. Since the Committee did not have enough money to pay off their debts, the candidate Richard Austin contributed his personal check of \$6,745.87 to pay off the balance. Mr. Davidson agreed to file these amendments with the Commission by August 3, 1978, one week after his verbal explanation. A copy of Austin's check, an explanation of where Austin got his money to contribute, and an accounting for the debts/obligations owed as well as those paid, were to be included in these amendments.

On August 7, 1978 the Commission received a brief letter from Mr. Davidson on behalf of the Austin for Senate Committee.^{*/} In the letter Mr. Davidson does not account for all of the Committee's outstanding debts and obligations nor does he explain how certain debts were diminished. Furthermore, the Austin for Senate Committee has not filed its year end report.

Recommendations:

(1) Except for possible review at the end of the year, take no further action and close the file with regard to: Don Bartlett for U. S. Senate Committee, Terry Miller's Alaska 1st Committee, and Erwin for Senate Committee.

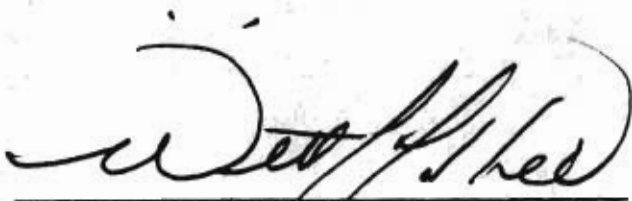

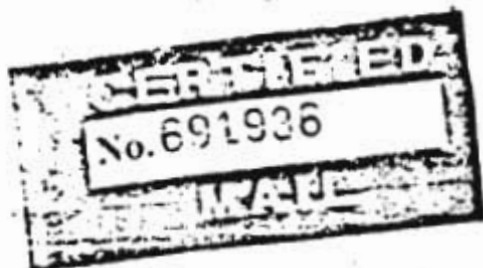

GENERAL COUNSEL'S REPORT

Background

On April 4, 1978, the Disclosure Division referred to the Office of the General Counsel the names of thirteen Senate candidates and committees who had failed to file their 1977 year-end report with the Federal Election Commission. For each of the thirteen candidates and committees the Commission found reason to believe and reasonable cause to believe that 2 U.S.C. § 434 had been violated. Attempts were made to notify each respondent of the Commission's findings.

Analysis

The Office of General Counsel reviewed all the reports filed by these Senate candidates and committees. Subsequent to the referral by the Disclosure Division

the 1977 year-end report was filed by Terry Miller's Alaska 1st Committee.

Four respondents are being handled by MUR 566 because they are multi non-filers and were referred with another group to the Office of the General Counsel for further action. They are: Gifford for U.S. Senate, Thurmon Jerome Hamlin President '80, Governor '79, U.S. Senate '78, Trenton H. Parker Senate Campaign Committee, Inc., and Gifford, Howard L. (Chips).

The Committee to Elect Etchison U.S. Senate '76, the Committee to Elect Shannon, the Don Bartlett for U.S. Senate Committee, and the McInerney, Joseph F., are new committees which have not yet filed any report with the Commission.

Three of the remaining four respondents, Erwin for Senate Committee, McInerney for U.S. Senate Committee, and Watson, Andrew J., report receipts and/or expenditures which do not exceed \$1,000 at any reporting time in 1977. It appears at this time that none of these committees have any significant outstanding debts.

The final respondent, Austin for Senate, filed a termination report listing receipts of \$6,745.87 and expenditures of \$11,597.31. The treasurer of Austin for Senate was contacted on March 13, 1978, and informed of the proper way to file a termination report. He agreed to file the forms at the end of the April 10, 1978 reporting period.

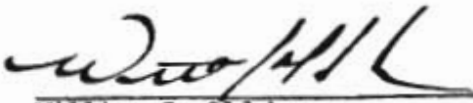

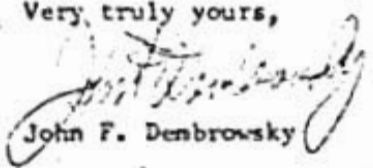

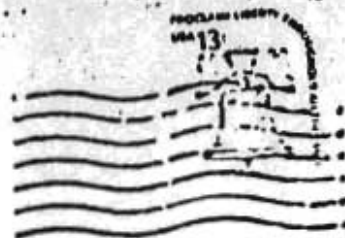

After making many phone calls I was able to determine that Mr Hamlin does not have a phone. On a previous call he made to me, he told me that he lived in a motel and gave me a phone number. Both the motel and the phone number appear to be non-existent. I called London Ky to see if I could get a cross reference on his address and match it with a motel (or anything similar). The person who answered the phone at city hall said that as far as she knew, there was no motel, boarding house or anything else at the address listed on the form 2, however this person said that she knew Mr. Hamlin quite well. It appears that Mr. Hamlin is somewhat of a town "fixture". The person who was giving me this information said that she would be putting it nicely if she said that Mr Hamlin was "not quite right". She said that he walks the streets constantly and verbally harasses any one who has the patience to listen to his ramblings. She indicated to me that although Mr. Hamlin spends a lot of time walking around, he has not been seen in the last few weeks. She suggested that I call the Sheriff's department and let them know that I wanted to talk to him.

FROM: Chip Foley to the Sheriff's Office of London KY

I called the Sheriff's Office and talked to the receptionist. The Sheriff and all the Deputies were out. I told her that I was calling from the FEC and that I had been referred to the Sheriff's office by City Hall. I told her that I needed to get in verbal contact with Mr. Hamlin to complete some business between himself and the FEC. This person also gave me the same story that I got from city hall indicating that Mr. Hamlin is well known in London for his strange and unpredictable ways. I gave her the toll free number and asked her if she would have the Sheriff or one of the Deputies give me a call. She said that she would give my number to the Sheriff's staff and they in turn would give it to Mr. Hamlin in their travels with the instruction to call the FEC as soon as possible.
