Dear Mr. Jordan:

I am responding to your letter of January 14, 2005, to Kris Warner in the above-captioned matter.

It is true that in the general election of 2004 in the State of West Virginia campaign yard signs appeared in support of President Bush and West Virginia Republican gubernatorial candidate, Monty Warner, stating, "Bush/Warner". These signs contained a disclaimer saying, "Paid for by the Northeast Conservative PAC". Mr. Warner at the time was serving as the Chairman of the West Virginia Republican Party. He was not a member of his brother's campaign staff or organization, although he certainly supported his candidacy both for familial and partisan reasons.

Mr. Warner and his wife did make contributions to the Northeast Conservative PAC in late September, 2004. The first contribution was written on the account of Kristian E. Warner and his wife, Joyce M. Warner, dated September 27, 2004, in the

amount of \$4,000.00 made payable to the Northeast Conservative PAC against his account at First United Bank & Trust, Oakland, Maryland, 21550. A copy of that check is attached hereto as Attachment A. By an examination of the back of the check it appears that that check was deposited on October 5, 2004. The second contribution made by Mr. Warner was by way of a check written to him from his brother's gubernatorial campaign. That check numbered 2138 dated the next day, September 28, 2004, in the amount of \$3,002.28 was signed over by Kris Warner paid to the order of Northeast Conservative PAC. An examination of the back of that check obtained from the campaign treasurer also shows it being deposited in the same bank on October 5, 2004. A copy of that check is attached hereto as Attachment B. Both checks were left by Mr. Warner for Sam Pimm to forward to the PAC, with the instructions that Mr. Warner be credited with a \$5,000.00 contribution (\$3,002.28 check plus \$1,897.72 from the joint account check) and that his wife be credited with a contribution of the remainder of the first check, or \$2,028.28.

The check written to Kris Warner from his brother's campaign indicates a memo of "Reimb of Expenses" and was in fact a reimbursement of expenses advanced by Kris Warner on behalf of his brother's campaign. In support of that amount, please find attached hereto as Attachment C credit card statements and statements of debit card withdrawals of Kristian Warner redacted to show the reimbursable expenses he incurred on behalf of the campaign. Also attached to Attachment C is a summary of those expenses in a listed typewritten form.

Prior to the time in question, Mr. Warner had never heard of or had any dealings with the Northeast Conservative PAC. Mr. Warner was not and has never been a director or officer of the Northeast Conservative PAC. Furthermore, Mr. Warner has never had the responsibility to file any reports required by the Federal Election Commission on behalf of the Northeast Conservative PAC.

The letter of Mr. Bolen to your office dated January 5, 2005, makes reference to newspaper articles and television reports. As with any media reports, some may be factual and fewer complete. With regard to the allegations of Dick Leggitt, sometime during the end of Mr. Warner's brother's campaign for Governor, Mr. Leggitt got in a dispute with the campaign with regard to the fees Mr. Leggitt was charging. While, and perhaps since, that matter was resolved for a tiny fraction of the amount

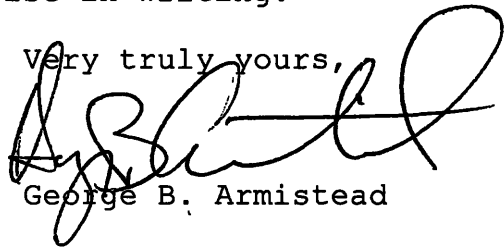

of fees Mr. Leggitt was claiming, Mr. Leggitt continues to harbor ill will against Mr. Warner's brother and all those associated with his campaign and the West Virginia Republican Party.

On behalf of Mr. Warner, I respectfully request that the Commission determine there is no reason to believe he has committed any violation of the Federal Election Campaign Act. Also on Mr. Warner's behalf, I request that this matter remain confidential until I advise otherwise in writing.
