As we discussed, Mark Hulkower and I represent MZM Inc. and the MZM Inc. PAC in this matter, as confirmed by the attached designation of counsel forms. This letter will confirm our request, on behalf of MZM, Inc. and the MZM, Inc. PAC, for a 30-day extension of time to respond to the complaint that we recently received from the FEC. We need the extension because, among other reasons, federal law enforcement officials recently executed a search warrant at MZM Inc.'s offices and we need time to identify the documents and information related to the complaint. Since we received the complaint on approximately July 7, 2005, the original 15-day deadline fell on approximately July 22, 2005. Accordingly, we respectfully request that the General Counsel's Office extend the deadline to respond to the complaint for an additional 30 days until August 22, 2005.
