Dear Mr. Norton:

A review of FEC reports recent filings of Stephanie Summers O'Neal for US Congress (Committee ID: C00395863) revealed the following violations of the Federal Election Campaign Act of 1971 (FECA), as amended. The following outline provides details violation of our campaign finance laws:

1. As of October 28, 2005, the Committee has failed to file the required October 15 Quarterly Report. As the Committee has outstanding debts totaling \$4,065, it is obligated to report them until they are satisfied.
2. The Committee, in September, filed a termination report. This termination report covers all or part of six (6) different filing periods. Federal campaign law requires that each reporting period be explained in a separate report.
3. The Committee has changed Treasurer's without first notifying the Commission by way of an amended organization statement.

The Committee has clearly violated the letter and spirit of our campaign finance and election laws. I trust that a prompt and full investigation into these charges is forthcoming. If additional information is needed, please contact me.
