I. Brief Introduction

During his time in office Rep. Bob Filner (CA-51) (hereinafter "Filner"), through his campaign committee, Bob Filner for Congress (id# C00261388), has repeatedly conducted re-election campaigns. As part of these campaigns, Filner has employed his wife, Jane, as a campaign consultant, paying money to her business: "Campaign Resources" (As is later explained this "business" is not even a registered shell of a company, the money goes simply to her), thus enriching his family and himself as well, (under community property laws) from donations made to the re-election campaigns.

Simply put, a portion of dollars (so far over half a million dollars as reported by Caitlin Rother in the San Diego Union-Tribune) given directly to Filner's "campaign" from various political action committees, individuals, business owners and other special interest groups have been diverted directly to the Filner household accounts. (Note: as later explained, Filner is certain by his own admission that contributors are fully aware that the money is going to his household accounts).

Those facts have been admitted by Filner on various television broadcasts, public forums (including one witnessed by Attorney Jesse Mallinger on December 4, 2005 at the Carlsbad Democratic Club), and have not been disputed by Filner at anytime. (It has also subsequently been revealed that Filner's wife's Consulting "Company" was a phony, or a sham, company and instead simply a name by which Filner could transfer monies to his wife. See attached news article in San Diego Union Tribune by Caitlin Rother.)

This questionable fundraising scheme comes to light at a time when the public's cynicism has reached an all-time high. First, Congressman Cunningham admitted to enriching himself with \$2.4 million in bribes. Second, lobbyist Jack Abramoff plead guilty to a far-reaching congressional bribery scheme. Filner's conduct of personal enrichment through a "sham" company deserves no less scrutiny and is equally reprehensible as he has deprived the public of honest services of government.

II. Statement of Complaint

Payments to family members from campaign contributions are only legal so long as they are "legitimate" and "bona-fide" for services actually rendered. In total, Filner has *managed to divert approximately \$500,000 from campaign contributions to his wife's non-existent, non-registered "consulting company" (which of course landed in his family's bank accounts)* ostensibly for "consultation." (Payments by the Filner campaign at that time to his wife was reported by Filner, and supported by documents enclosed herein.)

Furthermore, the bizarre circumstances surrounding the Filner fundraising company demonstrate that it is a phony entity that furthers their fraudulent activity. "Campaign Resources" has no business records. It has no business license. It is not registered as required under law. It has no certificate of occupancy, no registered trade name and no federal tax identification number as required to do business under the laws of the District of Columbia. The "business" has no phone registered to it. In fact, outgoing phone lines are registered to a United States Senator with no connection to Filner. The "business" has no letterhead, no employees and no other clients. Filner also refused to allow reporters to ask questions of his wife and refuses to reveal his income tax reports.

Additionally, Bob Filner, in virtue of California law relative to community property, has a personal financial interest in each and every campaign contribution made to Bob Filner for Congress. In a San Diego Union-Tribune article, dated December 4, 2005, Filner states that, "Everybody in Washington and in San Diego who contributes to me knows that my fundraiser is Jane, so it's a pretty open situation." As such, those with business before the Congress or within Filner congressional district *know* that a monetary donation to the campaign will have a direct financial impact on Filner's very own household income and bank accounts.

The claim that that amount of money (over half a million dollars) might be justified as "legitimate" or "bona fide" expenses when, in fact, they are diverted to a sham company is extremely dubious at best and hereby claimed to be fraudulent, and a fraud upon the Federal Election Commission and the American people.

It is hereby respectfully requested, that all votes made by Filner during all times in which campaign contributions went directly or indirectly into his own household income be examined by the Federal Election Commission, specifically the fiscal impact his votes and actions had on those contributors who donated to the campaign and Filner's household. It is further requested that the Commission examine the proximity of Filner's actions and votes to the contributions, the "earmarking" of funds in the Safe Accountable Flexible Efficient Transportation Equity Act of 2005 for the benefit of campaign contributors whose money ultimately became part of Filner's household income, and all other explicit or implicit quid pro quo arrangements and public's deprived right to "honest services." Additionally, whether Filner's wife performed bona fide services for the amount of money (\$505,000) received, including but not limited to the month of January 2001 in which Filner-filed FEC documents suggest that Ms. Filner was paid \$7000 in a month that she raised under \$1200.

III. Conclusion

Upon review of the enclosed information, and further investigation of Filner's votes as relate to his contributors, it is respectfully believed that The Commission will find Filner's process of diverting campaign contributions directly into the accounts of his family and enriching himself violative of the letter of the law and openly hostile to the spirit of the laws of The United States of America.

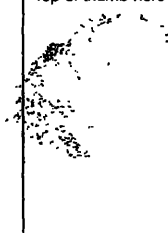

Lawmaker keeps wife on payroll

Filner is sole client of spouse's
unregistered consulting business

U.S. Rep. Bob Filner has paid at least \$505,000 in campaign funds to his wife for political consulting services since 1995. For the past five years she has run her unregistered business out of their condominium in Washington, D.C.

Filner has properly reported the payments to his wife's business, called Campaign Resources, on his campaign statements. He also has filed annual financial disclosure reports stating that his wife earns an undisclosed salary as a "self-employed consultant."

However, the District of Columbia government has no record of Campaign Resources existing as a business, and directory assistance has no phone listing for that name.

With no public records linking Jane Filner to her company, Bob Filner's constituents have no way of knowing that some of his campaign contributions are finding their way into his household's income.

Asked to prove the existence of his wife's business, Filner's campaign provided faxed copies of a blank check from an account at SunTrust bank and a sheet

of Campaign Resources letterhead with an outdated address and phone number.

It is illegal to spend campaign funds for personal use, but it is not illegal to use them to pay family members who provide "bona fide services" at fair-market value. Still, election watchdogs question the way the Filners set up their arrangement.

Larry Noble, executive director of the Center for Responsive Politics, said the question is whether "this (is) sloppiness or whether it's an attempt to hide that he's paying his wife for working for him."

Filner defended what he called "a perfectly legal arrangement" that was cleared with an attorney.

"Nobody's trying to hide anything," he said.

Jane Filner's only client is her husband, and for the past 11 years she has drawn what is essentially an annual salary from his campaign, though the amount varies from year to year.

She was paid \$60,000 for fundraising and political consulting services in 1998, when Filner had the luxury of run-

ning unopposed, the first time in 70 years a congressman in San Diego County faced no other candidate.

Campaign Issue

This year, Filner's three-time opponent, Assemblyman Juan Vargas, is making the payments a central issue of his campaign for the 51st District seat.

As in previous races, the two Democratic rivals are exchanging accusations of corruption. With the primary still six months away, this could be their ugliest battle yet.

"I think it's a practice that is absolutely the wrong thing to do and I think in some cases it could be legitimate, however (in this case) the appearance of impropriety is incredible," said Vargas, who is preparing a complaint to the Federal Election Commission.

Filner's response: "It's almost laughable, because he knows very well this is a perfectly legal situation. I have one of the best fundraisers in Washington, someone who I trust obviously, implicitly, and someone who has the respect all through Washington and San Diego for her professionalism."

"... She has offers from other congress people and other campaigns to work for them, but she can't — she's working for us full-time."

Filner contended that his longtime practice of paying campaign funds to his wife is

not only legitimate, but "irrelevant to the congressional campaign."

"What's wrong with that? Why is that a story?" he asked. He said Vargas is raising the issue to distract voters from important topics such as jobs, education and health care.

Although paying family members with campaign funds is not an uncommon practice in Congress, election watchdogs say it is controversial because it can be difficult to measure the quality and quantity of services being provided.

Bill Wachob, a La Jolla political media consultant who has worked for Filner's campaigns since 1991, said that is not the case here. The results of Jane Filner's work are incontrovertible, he said, because she has raised more than \$10 million for the campaigns since 1995. She started fundraising as a volunteer before that, he said, and has served as the primary fundraising consultant since then.

The \$10 million figure, however, turned out to be overstated.

Bob Biersack, a Federal Election Commission spokesman, said records show that Filner's campaigns raised a total of \$4.6 million from January 1995 through September 2005, which means her fee equates to 11 percent of all the money raised. During that same period, Biersack said, Filner's campaigns spent \$3.9 million.

Hiring family members can leave a candidate open to attack by an opponent, a strategy Filner himself used in his 1992 campaign for Congress.

In a campaign mailer, Filner ridiculed his Republican opponent, Tony Valencia, for using almost half his campaign contributions to "buy expensive suits

and to put his wife on the payroll."

Two years later, Filner sought legal advice before putting his wife on the campaign payroll. A memo he released from his law firm, Perkins Cole, said the practice was legal, but cautioned "there may be political risks. . . . Congressman Filner's opponent might raise the issue . . . and even file a formal complaint, regardless of its lack of merit, with the FEC."

National scrutiny

The issue of paying campaign funds to family members gained national attention earlier this year when it became public that Rep. Tom DeLay, R-Texas, had paid more than \$500,000 to his wife and daughter since 2001. In September, DeLay was indicted in Texas on unrelated charges of conspiracy in a campaign finance scheme.

Vargas initially complained about the payments to Filner's wife in an article published in *The San Diego Union-Tribune* in April. He brought his concerns to the newspaper's attention again recently after learning the payments totalled more than \$500,000 and that the District of Columbia had no record of the company.

To operate a home consulting business in Washington, D.C., officials there said the business owner must obtain a certificate of occupancy from the district government and register a trade name and federal tax number. They said Campaign Resources has done none of the above, which could lead to a notice of infraction and fines of at least \$2,000.

Wachob said Filner's campaign consulted with an attorney again after hearing this from the *Union-Tribune* and was advised that only one issue with Jane Filner's business needed to be remedied.

"It appears that she does need to register a trade name, and it does appear that that was an oversight and a mistake and that she will comply with that," Wachob said.

Ethics questioned

Officials from two national election watchdog agencies in Washington said the confluence of factors surrounding Filner's arrangement with his wife raises questions of both business and political ethics.

"It's not uncommon that members will pay their family in a campaign setting, but in this case, it does raise ques-

tions in terms of the quality of the disclosure," said Mike Surrusco, director of ethics campaigns for Common Cause. "If this is not an official entity, what is it? And why isn't it an official entity seeing how it's been operating like this for years?"

Noble, with the Center for Responsive Politics, said the fact that Filner's wife has no other clients contributes to the appearance that he is trying to hide their arrangement.

Filner said he generally agrees with people from the Center for Responsive Politics and has worked with them on campaign finance reform, but he disagrees with them on this issue.

"Everybody in Washington and in San Diego who contributes to me knows that my fundraiser is Jane, so it's a pretty open situation," Filner said.

Filner said he solicited bids to make sure her fee was at market rate before putting her under contract, and he rechecks that fee periodically.

"We're paying her far less than other people in similar positions make and what she could make on the outside, but we like to work together," Filner said.

Filner said his wife has a dedicated business phone line in their condominium, and he provided the number to the *Union-Tribune*. The number was listed in directory assistance as being registered to "Friends of Max Baucus." On the answering machine message, Jane Filner identifies herself by name, but never mentions Campaign Resources or fundraising. Max Baucus is a U.S. senator and a Democrat from Montana.

Filner's campaign said the number is a "Filner for Congress line," but directory assistance has no such listing. Wachob said Jane Filner has never worked for Baucus — a fact confirmed by the senator's chief of staff — at least as far back as 1996.

Initially, Filner told the *Union-Tribune* that his wife had obtained a business license as required and that he would fax a copy to the newspaper. Several days later, Filner said he had misspoken.

In the mid-1990s, he said, Jane Filner checked with local government officials and was told that a consultant didn't need a business license. He said she pays taxes like any other sole proprietorship.

Through Wacob, Filner re-

fused to produce tax forms that could back up that assertion. Filner also said he would not allow his wife of 20 years to be interviewed for this story.

"Employees don't talk to the press," he said. "Vendors who work for me don't talk to the press. That's our general policy. I talk for the campaign. If you have anything for the campaign, ask me."

A week after Filner made this statement, Wachob, also a campaign vendor, called the *Union-Tribune* to answer questions for this story.

Vargas said Filner's refusal to let his wife speak for herself only underscored questions about the legitimacy of the payments.

"This money is owed to her as a campaign professional and yet when asked if she can speak about it, he says 'No, she's my wife.' Wait a minute. Which one is it?" he said.

Jane Merrill married Bob Filner while she was working at the San Diego Local Agency Formation Commission, which oversees changes in jurisdictional boundaries and the organization of local government entities.

She started there as a staff analyst in October 1979 and was promoted to executive officer in mid-1984, said Mike Ott, who replaced her when she left in December 1992.

Jane Filner moved to Washington with her husband after he won his congressional seat. There, Wachob said, she worked as the executive director for a political action committee called Democrats 2000, now known as 21st Century Democrats, from May 1993 to December 1994.

Filner said his wife also worked for some other campaigns before joining his. He said she has a bachelor's degree in political science from San Jose State University and a master's degree in public administration from San Diego State University.

Ben Katz, another of Filner's campaign consultants in San Diego, said Jane Filner has always been involved in almost every aspect of her husband's campaigns.

"She's a nice person," Katz said. "She's also one of the smartest people I've had the opportunity to work with on campaigns. I know I personally learned a lot from her."

All in the family?

Filner's fundraising is less than transparent

You know an elected official has some explaining to do when, in looking at his actions, observers begin like this: "It may be legal but. ..." It's what comes after the "but" that gets you into trouble.

... But it sure looks bad.

... But it flunks the smell test.

... But it raises questions:

Take your pick. Either way, it's bad news for Rep. Bob Filner, D-San Diego, who has proven that Republicans aren't the only ones who can find themselves under ethics clouds.

For the last 10 years, Rep. Filner has used his campaign funds to pay at least \$505,000 to his wife, Jane, for what the Filners insist are legitimate political consulting services. Jane Filner earns an undisclosed salary for serving as — in Rep. Filner's words — "a self-employed consultant" in a business run out of the couple's condominium in Washington.

Most of the consulting at issue seems limited to fundraising, with Jane Filner having helped her husband raise in the neighborhood of \$4.6 million for his campaigns since 1995. Her half-million-dollar fee would amount to about 11 percent of that total. Professional fundraisers often charge as much as 20 percent for their services, according to Rep. Filner.

This may be a form of nepotism, but it's also perfectly legal — if it's done the right way. It's perfectly fine for an official to use campaign funds to compensate family members for professional services rendered at fair-market value. It's not even terribly original.

You may recall that the campaign apparatus of former House Majority Leader Tom DeLay, R-Texas, paid out about \$500,000 in

fees to DeLay's wife and daughter over five years for work they did on his re-election campaigns. When DeLay got into legal trouble for his alleged misdeeds, it had nothing to do with putting family members on the payroll.

The key is that anyone collecting money has to do actual work, and not simply profit from the fact that he or she is related to the candidate.

That may well be the case with the Filners, but it's difficult to say for sure. That's because there doesn't seem to be much hard evidence that Jane Filner's business actually exists. There apparently aren't many records. She has only one client: Rep. Filner. And the business isn't registered with the District of Columbia, as officials there told the *Union-Tribune* it is required to be by law.

Rep. Filner disputes that. He insists that Washington officials told him that a home-based consulting firm didn't have to be registered and that he received legal advice all along that left him confident that he and his wife weren't doing anything wrong. Of course, he says, now that the issue has come up, his wife will go ahead and register her company with the city.

That's a fine start. We would also hope that, from this point forward, the Filners keep better records of their dealings. Any work that Jane Filner does on behalf of her husband's campaigns needs to be spelled out in black and white, so that those who pay the bills — that is, the contributors to Rep. Filner's campaigns — can see where their money is going.

It may be that everything that has transpired here was totally innocent and above board, but. ...
