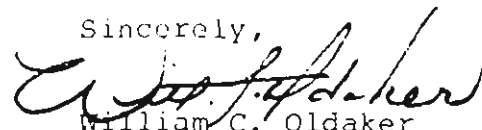
The Federal Election Commission has completed a preliminary review of your complaint and has numbered it as MUR 580 (78). Please refer to this number in any further correspondence.

GENERAL COUNSEL'S REPORT

BACKGROUND

This matter arose from a notarized complaint dated April 16, 1978, filed by Marvin Risenhoover. In the complaint Mr. Risenhoover alleges that the Mike Synar for Congress Central Committee ("Synar Committee") violated 2 U.S.C. §434(b) by reporting \$19,000 cash on hand in its 1977 Year End Report without disclosing the source of these funds.

The Synar Committee filed an amended Year End Report on April 3, 1978, which listed cash on hand as zero. \$8,749.06 of the \$19,000 originally reported was not explained by adjustments in the amended report.

On May 16, 1978, the Commission found reason to believe the Synar Committee violated 2 U.S.C. §434(b) and 11 C.F.R. §104.10.

ANALYSIS

In response to the Commission's reason to believe notification the Synar Committee submitted the attached material (Attachment I) which consists of a sworn statement by the

Committee Treasurer, Mr. Gene Moffitt, and a sworn statement plus attachment by the Committee's accountant, Mr. Elmer Hoffman.

Both Mr. Moffitt and Mr. Hoffman state that the Committee's original Year End Report was in error where it stated that cash on hand at the beginning of the reporting period was \$19,000. They state that the Committee's amended report accurately reflects cash on hand as zero.

According to their statement the \$19,000 error was the result of erroneously reporting a \$10,000 loan from the candidate as cash on hand and overstating receipts by \$9,000. This overstatement was due to counting a \$9,000 transfer from the Committee's checking account to its saving account as a \$9,000 receipt by the Committee.

In our first General Counsel's report we noted that the source of \$8,749.06 of the \$19,000 cash on hand was not adequately explained by the Committee's amended report. The \$250.94 difference between this figure and the \$9,000 overstatement of receipts consists of office expense in the amount of \$33.76 and office rent in the amount of \$217.18 (total \$250.94) paid by the candidate. These contributions in kind were not reported on the Committee's original Year End Report but were reported on the amended report.

In our opinion the material submitted by the Synar Committee adequately explains the discrepancies between the Committee's original and amended Year End Reports. Since the

amended report appears to be an accurate reflection of the Synar Committee's financial activity for the period concerned we believe the Committee is in compliance with 2 U.S.C. §434(b).

RECOMMENDATION

Find no reasonable cause to believe the Mike Synar for Congress Central Committee violated 2 U.S.C. §434(b) and 11 C.F.R. §104.10 by failing to disclose the source of \$19,000 cash on hand reported in its 1977 Year End Report. Send attached letters. Close the file.

The accounting for the Mike Synar for Congress central committee is performed by Elmer Hoffman, Certified Public Accountant, Muskogee, Oklahoma. Information pertaining to the first report of the Mike Synar for Congress central committee relating to the period ended December 31, 1977 is set forth in the affidavit of Mr. Hoffman attached hereto. Mr. Hoffman's affidavit indicates:

- 1) Cash on hand at the beginning of the period. As noted in Mr. Hoffman's affidavit, the beginning cash on hand was zero. The original return was in error when it stated that there was \$19,000 in cash on hand at the beginning of the period. The amended return correctly reflects beginning cash on hand as zero.
- 2) Cash receipts during the period. The affidavit of Mr. Hoffman indicates that there was omitted from the original return a loan from the candidate in the amount of \$10,000, office expense in the amount of \$33.76 and office rent in the amount of \$217.18. (AO 1977-12)

3) Expenditures. The original return omitted the office expense of \$33.76 and the office rent of \$217.18. (AO 1977-12) The amended return correctly reflects these items as expenditures during the reporting period.

4) Cash on hand at the end of the period. 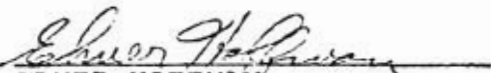

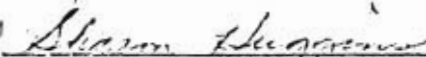

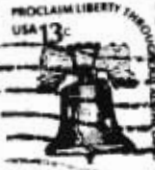

The Federal Election Commission has received a complaint which alleges your committee committed certain violations of the Federal Election Campaign Act of 1971, as amended ("the Act"). A copy of the complaint is enclosed. We have numbered this matter MUR 580 (78).

The Commission has found reason to believe that the matters alleged in the complaint state a violation of 2 U.S.C. §434(b) and 11 C.F.R. §104.10. Specifically, it appears that your committee failed to disclose the source of \$19,000 cash on hand at the beginning of the reporting period reported in the 1977 Year End Report filed on January 31, 1978. We note that your committee filed an amended Year End Report on April 3, 1978, however, the report fails to account for the full \$19,000 listed in the original report.

Under the Act, you have an opportunity to demonstrate that no action should be taken against you. Please submit any factual or legal materials which you believe are relevant to the Commission's analysis of this matter. Where appropriate statements should be submitted under oath.

We understand that, independent of this inquiry, the Commission's Staff Director will be contacting you for additional information concerning other discrepancies in your reports. These discrepancies are not part of MUR 580(78) and you should send the information requested directly to the address specified in the Staff Director's letter.

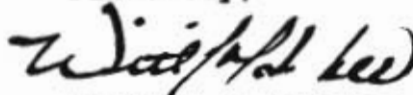

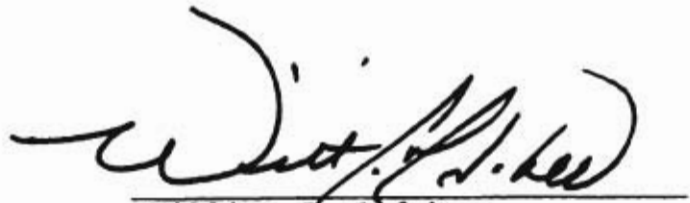

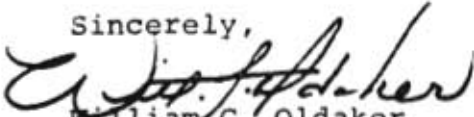

SUMMARY OF ALLEGATIONS

In a notarized complaint dated April 16, 1978, (Attachment I) Marvin Risenhoover alleges that the Mike Synar for Congress Committee ("Synar Committee") reported \$19,000 cash on hand in its 1977 Year End Report but failed to report the source of these funds in violation of 2 U.S.C. §434(b).

PRELIMINARY ANALYSIS

2 U.S.C. §434(b) requires a candidate or committee to report all funds received and to disclose the source of these funds. 11 C.F.R. §104.10 specifically provides that when a candidate or committee reports cash on hand at the beginning of the reporting period on its first report, the source of this money must be reported.

A review of the Synar Committee reports shows that the 1977 Year End Report was the first filed by the Committee. The report lists \$19,000 cash on hand at the beginning of the reporting period but fails to disclose its source.

On April 3, 1978, the Synar Committee filed an amended Year End Report in which the \$19,000 cash on hand is omitted. Receipts are listed as \$11,626.27 instead of \$1,375.33 as in the original reports. This still leaves \$8,749.06 unaccounted for. The amended report, therefore, does not appear to correct the failure to report the source of the \$19,000 cash on hand in violation of 2 U.S.C. §434(b) and 11 C.F.R. §104.10.

RECOMMENDATION

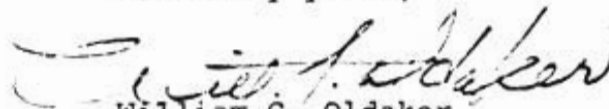

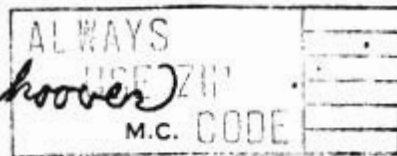

On Monday, April 17, I received a telephone call from Congressman Ted Risenhoover. He stated that his brother Marvin Risenhoover had filed a complaint with the Commission in February; that he had been notified by telephone that a complaint must be notarized; that Marvin Risenhoover thereafter mailed in a notarized complaint, on or about March 17, but had heard nothing.

A check with the mail room and with Carolyn Reed turned up a non-notarized complaint from Marvin Risenhoover dated February 23 and the notation of a telephone call by Carolyn Reed but no subsequent communication.

On Tuesday, April 18, I advised Congressman Risenhoover by telephone that we had no notarized complaint and that a new one would be necessary if we are to take any action. He said he would have a new one notarized and would send it down by messenger. As of this morning, April 19, I have not received it.
