Re: **Complaint against Stephen Harrison, Friends of Stephen
Harrison, Alice Harrison as Treasurer**

Dear Mr. Norton:

We respectfully file this complaint against Friends of Stephen Harrison (hereinafter "FSH"), principal campaign committee for Stephen Harrison, a candidate for the U.S. House of Representatives in New York's 13th Congressional District.

This complaint alleges four major campaign violations committed by FSH. These are: 1) Failure to report either payment for or an in-kind contribution of office space from the candidate's place of employment, 2) Acceptance of impermissible corporate contributions via campaign committees for State elections, 3) Acceptance of donations from an unregistered, illegal campaign committee, and 4) Acceptance of contributions from State committees for judiciary elections.

I. FSH does not report any in-kind contribution from or disbursement for office space provided by Harrison's law firm.

Harrison's campaign committee and his place of employment share the same address. As registered in FSH's Statement of Organization (March 21, 2006) and the firm's FindLaw directory listing, both are located at 544 Bay Ridge Parkway, Brooklyn, NY. See Exhibit A and Exhibit B. Clearly, FSH is operating out of Harrison's own law firm, the Law Offices of Stephen Harrison.

However, in reports filed with the FEC on July 15, 2006 and August 31, 2006, FSH neither discloses any rent payments made to the Law Offices of Stephen Harrison, nor are any in-kind contributions listed as received by FSH from the law firm. It therefore appears that FSH failed to report the amount spent on office space. We ask the Commission to investigate this glaring omission and whether the campaign paid for such office space and failed to itemize the disbursement or whether it never paid for its office in the first place.

In addition, if the Commission determines that the firm gave FSH office space as an in-kind contribution, we ask the Commission to investigate whether this constitutes an impermissible corporate contribution under 2 U.S.C. §441b(a), prohibiting corporate contributions to campaigns. The Commission has historically taken a dim view of the use of corporate resources in Federal elections. *See* MUR 5020 (Respondent Gormley for Senate Primary Election Fund, et al, total civil penalty of \$115,000) and MUR 5573 (Respondent Westar Energy, Inc., et al, total civil penalty of \$40,500).

II. FSH accepted contributions from illegal sources.

A. FSH accepted contributions from state campaign committees that had themselves accepted corporate contributions.

Federal law prohibits corporate contributions in “connection to any election for any political office, including local, State, and Federal offices.” 11 CFR § 114.2(a) and 2 U.S.C. § 441b. According to the July Quarterly, however, FSH accepted \$800 combined from two State campaign committees—Friends of Steve Cohn and Friends of Daniel O’Donnell—who listed corporate contributions in their filings with the New York State Board of Elections. *See* Exhibit C and Exhibit D.

We ask the Commission to investigate these contributions and determine whether these State campaign committees channeled corporate contributions to FSH in violation of federal law.

B. FSH has accepted contributions from an unregistered committee.

FSH lists two receipts from Friends of Ralph Perfetto, one for \$750 and another for \$812.81, on its 2006 July Quarterly Report (21/46). However, Friends of Ralph Perfetto is not registered with the Commission despite having contributed over \$1,000 this year. 11 CFR §§ 100.5(a); 102.1(d). Ralph Perfetto has also contributed \$530.28 as an individual to FSH.

However, Friends of Ralph Perfetto was terminated as a Committee with the New York State Board of Elections in 1997. Nor has Friends of Ralph Perfetto filed any reports, as an active committee, with that body as required by the New York State Board of Elections since that time. NY CLS Elec § 14-112 (2006). We urge the Commission to



investigate these troubling facts and determine how a non-existent committee made such contributions, and why FSH failed to detect this pattern itself.

III. Conclusion


At best, FSH and Alice Harrison, in her capacity as campaign treasurer, failed to determine the obvious illegality of these contributions. Given the disturbing nature of these violations—contributions made by corporations through state committees, a phantom committee, and candidates for judicial office—we respectfully request that the Commission: 1) investigate FSH's payment for office space and shady sources of contributions; 2) impose significant penalties against Friends of Stephen Harrison as appropriate; 3) prohibit Friends of Stephen Harrison from engaging in similar unlawful conduct in the future; and 4) levy such other remedies as the FEC finds appropriate.
