Please treat this letter as a formal complaint against Marty Blessinger and the Blessinger for Congress campaign

I have reason to believe Mr Blessinger and his campaign have failed to properly report known campaign expenses and in-kind contributions with the Federal Elections Commission Below, please find a listing of documented campaign expenses that have not been reported as of the August 31, 2006 filing

- 1 Up to 200 light box advertisement displays affixed to the top of taxicabs in the district. The advertisement reads "Marty Blessinger for Congress" (See attached photo A) According to Clear Channel Taxi Media, who sell the advertising space, the display's cost \$42,000 00 per 100 tops. (See attached document 1)
- 2 Production of bumper sticker advertisements reading "Blessinger for Congress". (See attached photo B)
- 3 Production of large billboard advertisement reading "Marty Blessinger for Congress, For a Change" (See attached photo C)
- 4 Construction and maintenance of a campaign website, www.blessingerforcongress (See attached document 2)

The total cost for the above services and advertisements are valued far above the minimum \$5,000 00 expenditure limit required for FEC filings As of September 15, 2006, Mr Blessinger and his campaign have not accounted for the costs of any of the above listed items with the FEC This is in direct violation of FEC Code § 100 3(a) (1-4)

Mr Blessinger and the Blessinger for Congress campaign have failed to meet the filing requirements of a candidate for Federal office I request you open an investigation into the practices of Mr Blessinger and his campaign and take the appropriation actions in order to maintain equality in the 2006 election
