The following is the listing of eleven (11) instances in which I believe the FEC rules have been violated by Mr. Eric Nelson Roberson, candidate for the nomination of the Democratic Party for the 32<sup>nd</sup> Congressional District of Texas. The alleged offenses include the following:

- Failure to report funds received and keep accurate accounts as required by the FEC guidelines,
- Misleading donors by having multiple exploratory committees and switching office sought,
- Failure to report in-kind contributions from his employer,
- Failure to declare candidacy once spending/funding and activity threshold was passed and
- Multiple violations of the testing-the-water guidelines

The following is the list of particulars. In disregard to the FEC regulations governing exploratory efforts and declaration of candidacy, the following is alleged:

1. Accepting donations under a "Senatorial Exploratory Committee", Mr. Roberson collected \$9,300 from donors in Utah and New Jersey during the period of January 12 to March 7, 2007, far exceeding funds needed to travel, phone and do polling in Texas as allowed to test-the-waters before committing to being a candidate (See Exhibits B, D)
2. Expended money under "Eric Roberson Senate Exploratory Committee" beginning January 26, 2007 in violation of the FEC rules that disallow *multiple* exploratory committees and deceptively suggesting a race for the Senate (See Exhibit E)
3. Put up "Eric Roberson for Congress" web site on or before February 8, 2007 in violation of the prohibition of "public political advertising" while testing-the-waters (See Exhibit J)
4. Joined a candidate-endorsing organization May 2, 2007 in violation of testing-the-waters rules (See Exhibit E)
5. Donated \$2555.08 to another candidate's campaign in violation of testing-the-waters rules (See Exhibit F & G)
6. Bought beverages for another candidate in violation of testing-the-waters rules (See Exhibit K)



7. "Refunded \$2,555.00 donation" to another candidate without there being evidence of the other candidate having made the "prior donation", in violations of reporting of all funds collected or expended after declaration of candidacy (See Exhibit I)
- 8 Filed candidacy for *Congressional* office January 4, 2008 after twelve months of representing oneself as a *Senatorial* candidate, in violation of the spirit and intent of testing-the-waters guidelines and with the effect of deceiving donors (See Exhibit A)
- 9 Failure to file as a candidate immediately after February 8, 2007 when funding threshold and activities went far beyond polling, telephoning and traveling to test-the-waters. (See Exhibit A)
- 10 Use of an employer's office as a campaign headquarters constitutes an in-kind donation by Mr. Mulligan or the Mulligan Law Firm, where Mr. Roberson is an employee. There is no report of such in-kind donation in violation of the reporting rules (See Exhibit C & H)
11. An exploratory period extending from January 12, 2007 to January 4, 2008 would seem to have morphed into a candidacy if the prohibition of "activities over a protracted period of time" apply (See Exhibit A)

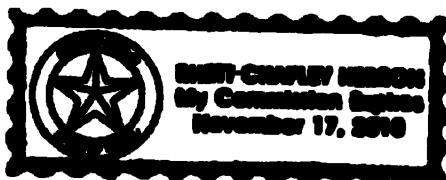

- Line 10 - Do FEC expenditures of exploratory committees include a \$2,000 donation to the exploratory committee of another candidate?
- Line 11 & 15 - Do FEC rules anticipate an expl committee of one person donating \$3,110.00 to the campaign of another candidate?
- When was AcBlue contracted with? (No date is indicated on report)
- Line 8 - Is enhancing web site with audio capacity consistent with exploration?
- Line 9 - Is membership in Democratic candidate endorsement group consistent with exploration?
- Line 6 - Is buying beverages for another candidate a legitimate exploratory expense?
- Line 12 - Is having "support staff" to use as in-kind donation to another campaign an exploratory function?



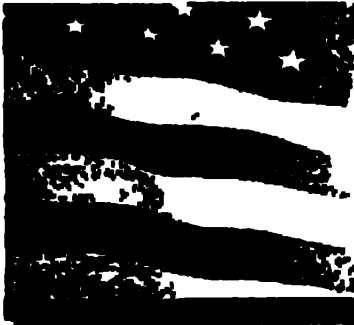
