COMPLAINT

NOW COMES the Michigan Republican Party, by its Executive Director, Jeff Timmer of 520 Seymour, Lansing, Michigan 48933 and hereby files this Complaint pursuant to 2 U.S.C. 437g(a)(1) and 11 C.F.R. § 111.4 against the above-captioned Respondents, and states the following:

1. On or about November 29, 2007, an entity called "Friends of Andrew Concannon" was formed pursuant to Section 527 of the Internal Revenue Code. See Exhibit 1 attached.
2. Friends of Andrew Concannon is not registered under the Federal Election Campaign Act or any other election authority. See Exhibit 1 attached.
3. Nonetheless, the stated purpose of Friends of Andrew Concannon is as follows:

"Campaign and fundraising committee/association organized for accepting donations and making expenditures for the purpose of electing Andrew Concannon to public office - an exempt function under law." See Exhibit 1 attached.
4. Friends of Andrew Concannon has paid for brochures on behalf of Andrew Concannon, a candidate for the United States House of Representatives in the 4th Congressional District of the State of Michigan. See Exhibit 2 attached.
5. On or about January 28, 2008, "Concannon for Congress" the principal campaign committee for Andrew Concannon, was formed. See Exhibit 3 attached.
6. The official website for Concannon for Congress is "www.concannonforcongress.com". This website is "powered by" Friends of Andrew Concannon, which is not registered under the Federal Election Campaign Act or any other election authority. See Exhibit 4 attached.

7. In an April 2, 2008 letter to the Federal Election Commission, Concannon for Congress replied to the Federal Election Commission on stationery paid for by Friends of Andrew Concannon, which is not registered under the Federal Election Campaign Act of any other election authority. See Exhibit 5 attached.

8. Friends of Andrew Concannon and Concannon for Congress are both located at the same address: PO Box 6958, Saginaw, Michigan 48608-6958. See Exhibit 1 and Exhibit 3 attached.

9. Although Concannon for Congress references Friends of Andrew Concannon as an "affiliated committee" on its FEC Statement of Organization (see Exhibit 3 attached), Friends of Andrew Concannon is not registered with the Federal Election Commission or any other election authority.

10. At the County Clare St. Patrick's Day Parade, the Concannon campaign purchased T-shirts, car signs, 4x8 signs, truck rental, trailer rental, balloons, baskets, candy, etc. (see Exhibit 6 attached); however, the April 15 Quarterly Report of Concannon for Congress only discloses \$224.87 in parade supplies, which is far less than the total of such expenditures. See Exhibit 7 attached. Consequently, upon information and belief, it must be assumed that these items were also purchased by Friends of Andrew Concannon, which is not registered under the Federal Election Campaign Act or any other election authority.

11. The Federal Election Campaign Act prohibits federal candidates or any "entity directly or indirectly established, financed, maintained or controlled" by a federal candidate from raising or spending funds in connection with a Federal election that are outside the contribution limitations, prohibitions and reporting requirements of the Federal Election Campaign Act. 2 U.S.C. § 441i(e).

12. In addition, Federal candidates may only raise and spend funds subject to the federal contribution limitation requirements; i.e., \$2,300 per election from individuals and non-multicandidate PACs, and \$5,000 per election from multi-candidate PACs. 11 C.F.R. § 110.1 and 110.2. The Federal Election Campaign Act and FEC regulations specifically prohibit a candidate from transferring funds or otherwise spending funds from a non-federal election to support a campaign committee for a federal election. 11 C.F.R. § 110.3(d).

13. As such, any entity established by a federal candidate must be registered with and regularly report to the FEC if the entity is raising or spending funds in connection with a Federal election. Federal candidates are not permitted to establish a separate 527 committee or other non-federal political committee for the purpose of raising and spending funds in connection with a Federal election, particularly their own Federal election.

14. Based on the foregoing:

a. Friends of Andrew Concannon, an entity that is not registered with the Federal Election Commission or any other election authority, is receiving contributions and making

expenditures in connection with a federal election, in violation of the Federal Election Campaign Act and numerous regulations of the Federal Election Commission.

b. Andrew Concannon, a federal candidate, is upon information and belief, raising funds for Friends of Andrew Concannon in violation of 11 C.F.R. § 300.61.

c. Concannon for Congress is receiving in-kind contributions from Friends of Andrew Concannon, which potentially may be from sources that are not permissible under the Federal Election Campaign Act and/or the regulations of the Federal Election Commission.

d. It remains unclear whether this 527 committee, Friends of Andrew Concannon, is raising funds from corporations or other prohibited sources, or "double dipping" by accepting contributions from individuals who have already contributed to his authorized campaign committee.

REQUEST FOR RELIEF

Based on the foregoing, the undersigned respectfully requests that the Federal Election Commission investigate these violations and determine that the Respondents have violated the Federal Election Campaign Act and the regulations of the Federal Election Commission.

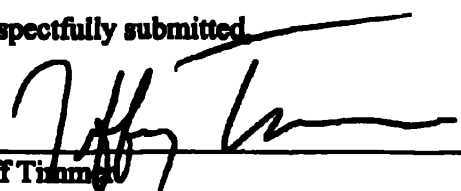
Further, the undersigned respectfully requests that the Federal Election Commission conduct a thorough review of the Respondents' records, in order to discover further violations of the Federal Election Campaign Act and the regulations of the Federal Election Commission.

Further, the undersigned respectfully requests the Federal Election Commission to assess all appropriate penalties for said violation(s) in accordance with 2 U.S.C. 437g(a)(5)(A), or any other enforcement provisions of the Federal Election Campaign Act.

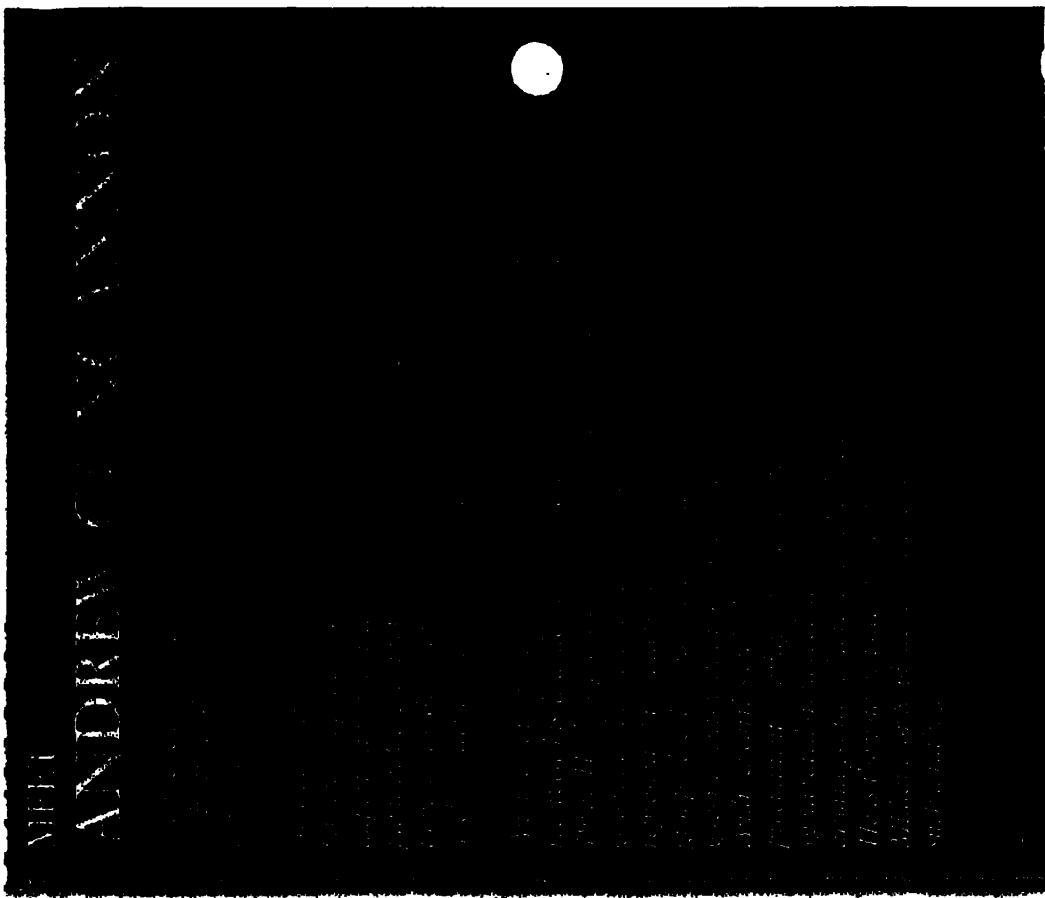

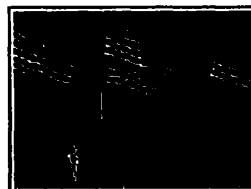

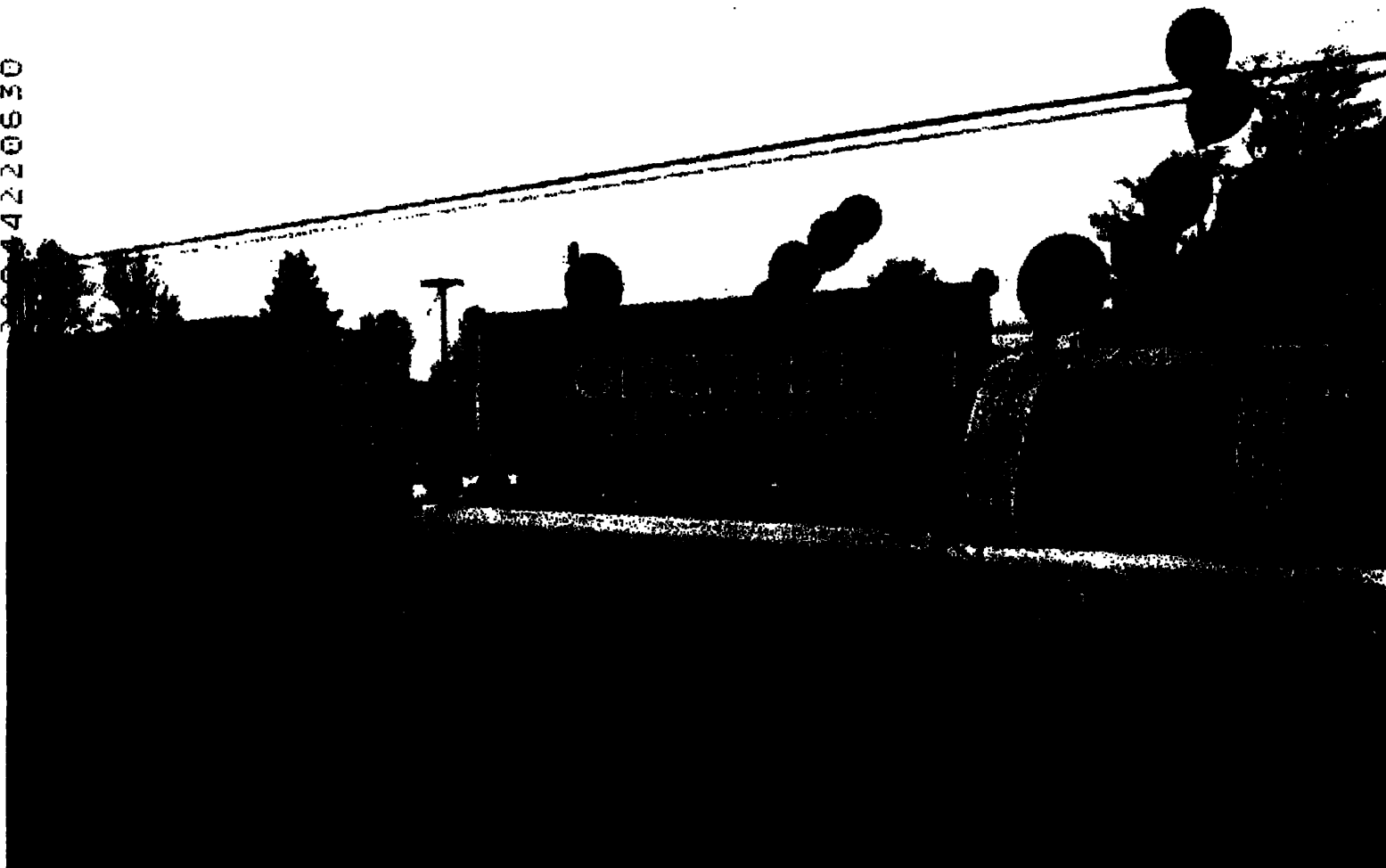
