Dear Mr. Jordan

Enclosed please find two (2) signed Statement of Designation of Counsel forms authorizing me to act as counsel for the Ohio Bankers League and Daniel K. Conklin in the above-entitled action

The complaint in MUR 6033 was served on the respondents on July 14, 2008. As you know, 11 C.F.R. § 111.6(a) provides that a respondent may file a written response to a complaint within fifteen (15) days of receiving it. Since the respondents were served on July 14, 2008, a response is due next Tuesday, July 29, 2008.

Although I have initiated an investigation into the allegations of the complaint, there will not be sufficient time to complete that effort and file a written response by July 29, 2008. In order to prepare a complete response, I will need to interview a number of employees of the Ohio Bankers League who have direct knowledge of the events alleged to have occurred in the complaint. As you can imagine, many of these witnesses have long-standing travel plans for the months of July and August. Indeed, one of the central witnesses in this MUR is currently out of the country and will not return until the last week of July. In addition, counsel also has long-standing travel plans that dovetail with those of the witnesses in this MUR. Accordingly, I
