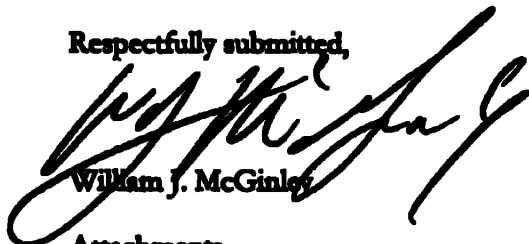

Sua Sponte Submission of Vern Buchanan for Congress

Pursuant to the Federal Election Commission's ("Commission") Policy Regarding Self-Reporting of Campaign Finance Violations (Sua Sponte Submissions) ("Self Reporting Policy") that took effect on April 5, 2007, Vern Buchanan for Congress ("VBFC" or "Campaign"), through counsel, makes this sua sponte submission concerning possible campaign finance violations recently brought to the Campaign's attention. As explained below, VBFC has taken immediate corrective actions concerning the potential violations at issue in this matter and is making a timely disclosure to the Commission. The information contained in this submission is based on information and belief.

The relevant information in this matter came to light during the course of threatened commercial litigation between Mr. Buchanan, in his personal capacity, and Sam Khazran, the person in charge of business operations at two automobile dealerships in which Mr. Buchanan had a financial interest, Hyundai of North Jacksonville ("HNJ") and Premier Dodge. Specifically, Mr. Buchanan's representatives received information in September 2008 that contributions from certain HNJ employees and their family members were reimbursed by the business. Hyundai of North Jacksonville is located at 3333 North Main Street, Jacksonville, Florida 32206.

After investigating this information, Congressman Buchanan's representatives and VBFC performed a review of the Campaign's relevant periodic disclosure reports and contribution records. The contributions at issue in this matter are as follows:

Copies of the applicable disclosure reports listing the contributions identified above are attached as Exhibit A. Copies of the contribution checks received by the campaign from these contributors are attached as Exhibit B.

As can be seen from the copies of the contribution checks, the contributions are all facially permissible under Commission regulations. Each check was drawn on a personal or joint checking account and the amounts comply with the applicable contribution limits for the election cycle in which the contributions were made and received by the Campaign. Some of the contribution checks were appropriately redesignated or reattributed in accordance with Commission regulations.

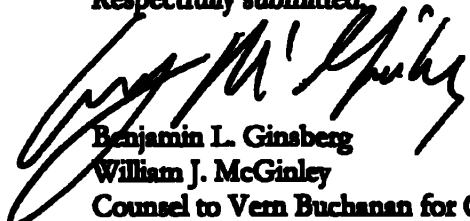
VBFC's actions in this matter comply with the Commission's Self-Reporting Policy. First, the Campaign performed a review of records and filings after learning of the alleged violations.

Second, VFBC has internal controls designed to detect and refund any facially impermissible donations made to the campaign. The contributions at issue in this matter, however, were facially permissible and there was no apparent reason to question the contributions at the time they were received by the campaign. Third, VBFC does not believe that the individuals who made these contributions or the business that allegedly reimbursed them should profit from their actions. Thus, VBFC has placed \$52,000 in reserve and hereby requests the Commission's guidance concerning whether the Campaign should refund the contributions to the contributors, or disburse the funds to a charity or the U.S. Treasury.

For the foregoing reasons, VBFC makes this voluntary submission pursuant to the Commission's Self-Reporting Policy and awaits the Commission's guidance on the proper recipient for the funds at issue.
