Pursuant to our telephone conversation this afternoon, I am enclosing the completed Statement of Designation of Counsel for Meakem Communications Company LLC in the above matter. Separately, Meakem will forward by fax its authorized signature. This will also confirm my request for an extension of 30 days within which to respond to the complaint. My client intends to file a response, and since I believe the first 15 day period for a response may expire tomorrow, I would appreciate it if you would advise me as promptly as possible whether this extension has been granted.

Preparing a response may require us at a minimum to examine the status of Meakem Communications Company LLC, its elections for tax purposes, the contractual relations with the radio station, the details relating to the time and cost of the radio broadcast in question and preparation of a verified response with appropriate documentary exhibits. Therefore, we believe that 30 day extension is reasonable under the circumstances.
