

AFFIDAVIT

FEC COMPLAINT REGARDING TURK FOR CONGRESS

I, Stephen R. Bough, being first duly sworn, hereby state and attest as follows: 2008 OCT 28 P 2:14

1. The undersigned has personal knowledge of the facts set forth.
2. Stephen R. Bough resides at _____, Kansas City, Missouri, 64113.
3. There are numerous yard signs (both large and small) throughout the Kansas City area.
4. There are at least five different billboards throughout the Kansas City area.
5. These billboards are within the metropolitan area along our busiest highways.
6. Based upon prior personal phone calls, these billboards (owned by CBS outdoor advertising) cost literally thousands of dollars per month.
7. There are two publicly accessible Turk for Congress campaign disclosures; one dated April 16, 2008 and one from July 28, 2008.
8. The April report lists an expenditure of \$500.00 for advertising to Connova Outdoor Sign Company.
9. The July report lists an expenditure of \$2,407.51 for signage to Jo Ann Signs.
10. Neither report lists any in-kind donations for advertising, signage or bill boards.
11. Attached to this affidavit is a true and accurate copy of an email circulated from the Turk for Congress campaign. The yard signs and email are misleading in that they do not say Turk is running "for" congress and imply that he is the congressman already.
12. This email references the cost of yard signs being roughly \$2,000, which would correspond to the Jo Ann Signs expenditure from July.
13. Either someone besides the campaign is paying for the billboards or the bill boards were an in-kind donation that was not reported. Either way, it would be an illegal corporate subsidy.
14. These billboards were not reported as a campaign contributed or expenditure, in violation of the Code of Federal Regulations, Part 110.

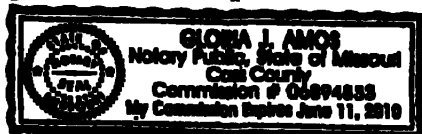


