Formal Complaint;

To Whom It May Concern:

I would like to file this formal complaint with your office: I am complaining that my Labor Union, BLET (Brotherhood of Locomotive Engineers and Trainmen) who is affiliated with the Teamsters Union has violated the Federal Election Campaign Laws. Enclosed with this complaint is a copy of an email that I received from my BLET Local 662 chairman; Rudy Borrego. The email was forwarded to me by Rudy from our State chairman Tim Smith. As you can see by the chain of events in this email activity, I attempted to stop this unlawful campaign activity with Rudy Borrego and Tim Smith directly. Rudy Borrego refered me directly to Tim Smith because he was the person who originally sent the email out canvassing for volunteers. As you can see by my response and that response from Mr. Smith, my complaint fell on deaf ears. Mr. Tim Smith's original email clearly violates the Law in my opinion by his canvassing effort specifically for, "Helping the Democratic Campaign". This is intensified by his statement that, "Again, your expenses and a daily rate of \$235 will be covered by the National". The term National means the Teamsters National.

It is my understanding that this is a violation of Election law.

Corporations and Unions

The Law also prohibits contributions from Corporations and Labor Unions.

It is further defined that a contribution is;

What is a contribution

Most people think of contributions as donations of money in the form of checks or currency. While these are common ways of making a contribution, anything of value given to influence a Federal Election is considered a contribution.

My charge is that this Labor union is in fact contributing to the Democratic Party by paying members with BLET dues money to activly join and campaign for the Democratic Party. The BLET is in fact trying to influence our Federal Election. These chairmen are not acting as private individuals, they are acting on behalf of the BLET.

My interpretaion of the Law as it is written on your website is very clear. It simply is illegal for a Labor Union to make a contribution to a Federal Campaign. I believe that The evidence attached to this complaint is very clear as to the intentions of the BLET. I believe that the BLET is trying to influence this Election while operating under their title as a Labor Union. This is evidenced by their own admission that they will pay members to campaign. As you can see Tim Smith used his Union title, Tim Smith, Chairman, CSLB/BLET/IBT Rail Conference.
