
Dear Mr. Jordan:

This is in response to Matter Under Review 6138; that alleges the Honeycutt for Congress Committee may have violated the Federal Election Campaign Act.

After discussing the matter with Mr. Andrew Honeycutt, the Campaign Chairman; it appears that a disbursement was made to 48 Hour Print on August 29, 2008 in the amount of \$1,385.75 and this expenditure was disclosed on Schedule B, Line 17, page 1200 of the 3<sup>rd</sup> Quarter 2008 FEC Report.

Mr. Honeycutt has been attempting to contact Mr. David Knox to obtain any additional information relevant to this matter. The committee will forward any relevant documents or information once obtained.

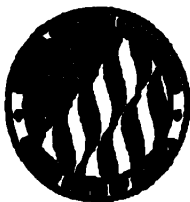
