Complaint of Over Limit Contributions and Request for Audit - Obama for America (C00431445) and Obama Victory Fund (C00451393)

Dear Sir or Madam:

This is a complaint pertaining to the Presidential Campaign Funds of Barack Obama. cursory examination of his donations shows numerous contributions exceeding campaign contribution limits. It is very disturbing to me how these campaign finances were handled.

Looking at just half the listings in Florida (last names ending C-L), there are 25 donors (listings attached) exceeding the limit of \$4,600 for a total of \$47,643 of donations in excess of the limit. Are these the people who are going to turn around our distressed economy? This is unacceptable and as an American citizen, I am requesting that you hold them accountable.

The American People need an audit of the Obama for America (C00431445) and Obama Victory Fund (C00451393). The sheer volume of transactions prohibits transparency. 



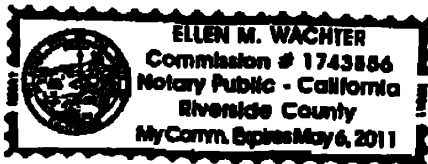
