Our company, Jamestown Associates, performed the media services for the Jim Ogonowski for Senate Committee. Mr. Ogonowski, the respondent, owes Jamestown Associates \$27,361.94 for media purchased on his behalf. We were promised on several occasions' payment for the media purchase but it remains outstanding. Mr. Ogonowski and his campaign are very much aware of this outstanding debt, yet it has not been listed in any of his past debt filings with the FEC. We intend to file suit to collect this payment, but we believe Mr. Ogonowski has a legal obligation to report such existing debt to the FEC.
