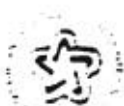

GENERAL COUNSEL'S REPORT

Allegation

Five (5) candidates and nine (9) campaign committees are in violation of 2 U.S.C. §434 for failure to file 10 Day Pre-Primary reports for the Pennsylvania Congressional primary held May 16, 1978.

Previous Commission Action

The Commission found reason to believe on May 8, 1978, and reasonable cause to believe on May 10, 1978, that in each case a violation of 2 U.S.C. §434 had occurred. The names of Pennsylvania non-filers appeared in the Commission's publication of May 13, 1978. On June 5, 1978, the Reports Analysis Division referred this matter to the Office of General Counsel.

Evidence

Certain published non-filers subsequently submitted reports of pre-primary financial activity. No candidate or committee aggregated receipts and expenditures in excess of \$25,000 for the entire 1978 pre-primary period. Late filing dates, as well data pertinent to the Pennsylvania election, are compiled below:

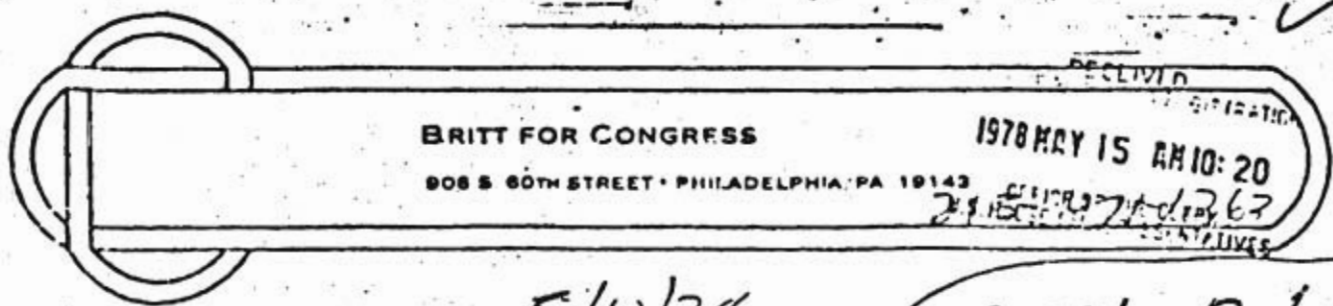

Milton J. Shapp in both 1966 and 1970. This time, he believed he had the issues and the momentum to make it. He had fought for eight years as state auditor against corruption and overspending. And he was well known throughout the state. The Philadelphia organization, while making no endorsement, was believed to favor his candidacy. But Casey failed to develop the margins in his strong areas — his native Northeast and Philadelphia — to overcome Flaherty elsewhere.

Kline was the closest thing in the campaign to a traditional liberal Democrat, and received significant support from labor and the organization. But his close ties to the corruption-ridden Shapp administration apparently prevented him from developing his potential support despite an energetic campaign. He ran third almost everywhere throughout the state, winding up with only 17.4 percent of the vote.

House Seats

In the congressional races, Nix was the only incumbent to lose. Gray learned the lessons of his losing 1976 effort, starting early, putting together an effective organization, and getting adequate funding. Nix's reliance on his congressional seniority and backing by the organization was not enough to overcome Gray's well-coordinated efforts.

In addition, Gray had the Rev. Martin Luther King Sr. into the district to speak for him. U.S. Ambassador to the United Nations Andrew Young also made appearances with Gray, although he claimed they were not political.

In the 4th District, Rep. Joshua Eilberg, D, who is under investigation for his role in gaining federal funds for a local hospital, easily overcame a challenge from state Rep. Mark B. Cohen, D. Cohen made an explicit issue of Eilberg's integrity, but Eilberg's longtime efforts at constituency service and his loyal backing by the organization proved effective. He beat Cohen two-to-one, with two other Democratic candidates trailing far behind.

Eilberg may have more trouble with his Republican opponent in November than he did in the primary. The Republicans will be making a major effort to capture the seat with state Sen. Charles Dougherty, who was unopposed for his party's nomination.

Two open seats in western Pennsylvania — the 21st, where Rep. John H. Dent, D, is retiring after 20 years, and the 25th, where Rep. Gary A. Myers, R, is leaving after only two terms — turned into political free for alls, with 15 candidates seeking nomination in the 21st District and 16 in the 25th.

In the 21st, Don Bailey, a Greensburg attorney with no previous political experience, spent a lot of his personal money on the Democratic race and built a strong volunteer organization. In an 11-person field, that was enough. It settled down to a two-way race between himself and Bernard

F. Scherer, the Westmoreland County Democratic chairman. Bailey edged him out by 209 votes. Running third was John A. Cicco Jr., D, who had run a strong race against Dent in the 1976 primary, drawing 37.4 percent of the vote. This time, he received only 15.4 percent of the vote, much of his former support having gone to other candidates.

On the Republican side, Robert H. Miller, the 1976 Republican nominee, edged out David L. Robinson, for the opportunity to try again.

In the 25th District, Beaver County asserted its dominance over the three-county district by backing the winning candidate in both party primaries. Beaver County Commissioner Eugene V. Atkinson won the Democratic nomination as he did two years ago. His strong backing in Beaver County put him way ahead of his nearest rival, Nick Colafella, a college communications director from Aliquippa, also in Beaver County. Lawrence County Commissioner Thomas A. Shumaker, thought to be Atkinson's main rival for the nomination, ran fourth. Former Rep. Frank Clark, D, 1955-75, ran a poor seventh.

On the Republican side, Tim Shaffer, who lost the Republican nomination in 1974 to Myers, easily overcame a high-spending effort by Dr. Raymond J. Saloom to win his party's nomination.

In the 8th District, Republicans chose a controversial county commissioner, G. Robert Bowers, as their candidate to try to unseat Peter H. Kostmayer, the Democratic freshman representative. Bowers was part of a county administration that approved the largest property tax increase in the county's history. He also has quarreled sharply with county Republican leaders, often on patronage issues, leading some to suggest that the local Republican organization would not be unhappy to see Bowers win and leave county government for Washington.

The Republican organization hoped to avoid the fratricide of two years ago when an emotional primary tore the party apart, weakening it for the general election. As a consequence, it stayed out of this year's primary. But the nomination of the controversial Bowers with only 34.3 percent of the vote may have continued the Republican rift and made their job of retaking the district more difficult.

In the 23rd District, Republicans chose William F. Clinger Jr., a Warren attorney, as their candidate to try to take the seat back from freshman Democratic Rep. Joseph S. Ammerman.

The regional division of the district between the sparsely populated rural counties in the northwest and the three southern counties of Centre, Clinton and Clearfield showed itself once again. Clinger, who is from the northwest, carried that area handily. His main rival, Jeffrey Bower, who is from Centre County, counted on large margins from the south. Bower carried Centre and Clinton but lost Clearfield.
