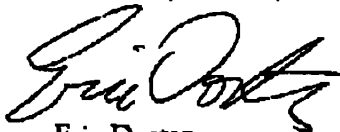

COMPLAINT

NOW COMES Jeff Timmer of 520 Seymour Avenue, Lansing, Michigan 48933, and hereby files this Complaint pursuant to 2 U.S.C. 437g(a)(1) and 11 C.F.R. § 111.4 against the Kalamazoo County Democratic Party Federal Committee, Carolyn Cardwell, Treasurer (hereinafter referred to as the "Committee"), Cooney for Congress Committee, Robert Snyder, Treasurer (hereinafter referred to as "Cooney"), and states the following:

1. The Committee is responsible for the day-to-day operations of the Democratic Party for the County of Kalamazoo, State of Michigan and is a local party organization pursuant to 11 C.F.R. § 100.14(b).
2. On or about October 4, 2008, the Committee filed its Statement of Organization with the Federal Election Commission.
3. Cooney is the principal campaign committee for Don Cooney, who was a candidate for the United States House of Representatives for the 6th District of the State of Michigan.
4. Attached as Exhibit 1 is the 2008 Post-General Election Report filed by the Committee to the Federal Election Commission, which indicates that \$11,214.35, received by the Committee on seven specific dates, constituted "anonymous cash contributions under \$50 each."
5. Upon information and belief, the Committee knows, or should be able to determine those contributors of the "anonymous contributions." If a committee knows, or should be able to determine, the names of the contributors, such contributions are not "anonymous" contributions for the purposes of 11 C.F.R. § 110.4(c)(3). See Advisory Opinion 1991-20.
6. Upon information and belief, because these "anonymous" contributions have not been reported, the funds in the Committee's accounts may contain funds which are not in compliance with the prohibitions and limitations of the Federal Election Campaign Act. A political committee is prohibited from knowingly accepting a contribution that violates the prohibitions on contributions. 11 C.F.R. § 110.20(g), 11 C.F.R. § 110.4(b)(1)(iv), 11 C.F.R. § 114.2(d), and 11 C.F.R. § 115.2(c).

7. According to the Committee's 2008 Post-General Election Report attached as Exhibit 1, from October 18, 2008 through October 31, 2008, the Committee contributed \$5,000 to Cooney. Again, upon information and belief, these contributions from the Committee to Cooney may have been made with funds which were not in compliance with the prohibitions and limitations of the Federal Election Campaign Act. Campaigns are prohibited from accepting contributions from prohibited sources. 11 C.F.R. § 110.9.

REQUEST FOR RELIEF

Based on the foregoing, the undersigned respectfully requests that the Federal Election Commission investigate this violation and determine that the Committee and Cooney have violated the Federal Election Campaign Act and the regulations of the Federal Election Commission, as referenced above.

Further, the undersigned respectfully requests that the Federal Election Commission conduct a thorough review of the Committee's records, and the records of Cooney for Congress, in order to determine whether the contributions made to Cooney for Congress were derived from permissible sources pursuant to the Federal Election Campaign Act.

Further, the undersigned respectfully requests that the Federal Election Commission conduct a thorough review of the Committee's records and the records of Cooney for Congress, in order to discover further violations of the Federal Election Campaign Act and the regulations of the Federal Election Commission.

Further, the undersigned respectfully requests the Federal Election Commission to assess all appropriate penalties for said violation(s) in accordance with 2 U.S.C. 437g(a)(5)(A), or any other enforcement provisions of the Federal Election Campaign Act.

The above statements are true and accurate to the best of my knowledge, information and belief.

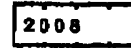
