**III. BACKGROUND:****Other Violations of the Federal Election Campaign Act (Unauthorized Disbursement of Committee Funds)**

During an internal review of its financial activity, the Leading Us in Success Political Action Committee (LUISPAC) ("the Committee") discovered unauthorized receipt and disbursement of Committee funds totaling \$23,500.00 and \$41,000.00, respectively, by the Committee's former Treasurer, Christopher J. Ward. These transactions were not disclosed on the Committee's reports.

On June 20, 2008, the Committee filed an Amended 2007 May Monthly Report covering the period from April 1 to April 30, 2007; an Amended August Monthly Report covering from July 1 to July 31, 2007; an Amended September Monthly Report covering from August 1 to August 31, 2007; an Amended 2008 February Monthly Report covering from January 1 to January 31, 2008, and an Amended 2008 March Monthly Report covering from February 1 to February 29, 2008.

The Amended 2007 May Monthly, Amended 2007 August Monthly, and Amended 2007 September Monthly Reports disclosed three (3) disbursements to Christopher J. Ward totaling \$40,000.00 on Schedule B supporting Line 29 (Other Disbursements) with the purpose "Unauthorized Disbursement" (Images 28991323800, 28991323649, and 28991323802). The Amended 2008 February Monthly Report disclosed one (1) \$1,000.00 disbursement to SAXPAC (Safeguarding America by Expanding National Security) on Schedule B for Line 29 (Other Disbursements) with the purpose "Unauthorized Political Contribution" (Image 28931953833). The Amended 2008 March Monthly Report disclosed one (1) \$23,500 receipt from Christopher J. Ward on Schedule A supporting Line 17 (Other Federal Receipts) with the purpose "Refund - Unauthorized Disbursement" (Image 28991324966) (Attachment 2).

On July 11, 2008, after reviewing the amended reports, the Reports Analysis Division (RAD) Analyst called to speak with Ms. Maria Sanchez Bras, the Committee's Treasurer, about the unauthorized activity disclosed on the Committee's amended reports received June 20, 2008. The Analyst left a message stating that the apparent unauthorized activity would need to be referred for legal action and left contact information with a request that Ms. Sanchez Bras return the call to discuss the matter in more detail (Attachment 3).

On July 16, 2008, the RAD Analyst called Ms. Sanchez Bras to discuss the apparent unauthorized activity disclosed on the Committee's amended reports. The Analyst told Ms. Sanchez Bras that the apparent unauthorized activity disclosed in the reports would need to be referred for legal action and asked if she could provide any additional information. Ms. Sanchez Bras stated that she had been contacted by the Federal Bureau of Investigation (FBI) and is currently working with them to provide any documentation of Mr. Ward's unauthorized activity. The Committee hired an outside firm to audit the Committee, after which the firm amended the Committee's reports to more accurately disclose their activity. The Analyst asked if the activity disclosed as unauthorized disbursements was the only discrepancy that the firm found, and whether the audit was still ongoing. Ms. Sanchez Bras stated that to her knowledge, the embezzlement took place as disclosed on the amended reports, and that Mr. Ward wrote checks, but did not keep copies, so the Committee is working with their bank to get copies of the checks. Ms. Sanchez Bras stated that since she is in Puerto Rico, lawyers have been hired to help the Committee with this issue and to work with the FBI in Washington, DC. The Analyst stated that someone from the Commission's legal division would contact her if additional information was required (Attachment 3).

To date, no further communication has been received from the Committee regarding this matter.
