To Whom It May Concern:

On behalf of Safeguarding America by Expanding National Security PAC, ("SAXPAC"), Committee ID C00409649, I submit this complaint for knowing and willful violations of the Federal Election Campaign Act against Christopher J. Ward, the former treasurer of SAXPAC.

Ward was the treasurer of SAXPAC from February 2005 until January 27, 2008. After submitting the termination approval and immediately upon learning through the media about the concerns the National Republican Congressional Committee ("NRCC") had with Ward's services as treasurer, SAXPAC began a review of its records. This firm was retained as counsel and Brad Dena was retained as treasurer for the purpose of filing amendments. SAXPAC filed the following amended reports on August 28, 2008 in order to correct reports from 2006-2008 that were determined to inaccurately reflect SAXPAC's financial activities:

- June 20, 2006;
- September 20, 2007;
- October 20, 2007;
- November 20, 2007;
- December 20, 2007;
- January 31, 2008; and
- February 20, 2008.

SAXPAC also filed two new reports (March 20 and April 20, 2008) detailing activity that occurred in its bank account after SAXPAC received termination approval from the FEC on January 27, 2008.

Pre-Termination Amendments

Identified Instances of Suspected Theft of PAC Funds

SAXPAC has identified two checks issued from SAXPAC to "Chris Ward" in late August 2007 representing payments to which Ward was not entitled. One check was dated August 20, 2007 in the amount of \$5,000. The other was dated August 24, 2007 in the amount of \$5,000. See attached. According to Elise Aronson, volunteer manager of SAXPAC, Ward was not entitled to receive these checks and neither disbursement was authorized by SAXPAC. Ms. Aronson believes that these checks may constitute both fraud and theft. Accordingly, the amended reports filed by SAXPAC declare these disbursements to be misappropriated funds. We believe that Ward commingled these PACs funds with his personal funds in violation of 2 U.S.C. § 432(b)(3).¹ We have little doubt that an investigation will demonstrate that these violations were knowing and willful. In addition, Ward failed to disclose these two checks on reports he filed with the FEC. This failure was in knowing and willful violation of 2 U.S.C. §§ 434(b)(4) and 11 C.F.R. § 104.3(b). The amendments submitted on the amended September 20, 2007, report reflect the actual activity in the bank account.

Uncovered Reporting Errors and Irregularities

In September 2007, October 2007, and January 2008, Ward filed FEC reports disclosing payments totaling \$4,000 to Political Compliance Services ("PCS"), which is a consulting company where Ward was a partner. SAXPAC's review, however, indicates that only a single \$500 payment to PCS was made.²

These same months' FEC reports also disclose payments totaling \$6,000 to McGahn & Associates. SAXPAC's review, however, indicates that only a single \$3,000 payment to McGahn & Associates was made, that was dated January 25, 2008 and was cashed on February 29, 2008 from SAXPAC's bank account.³ SAXPAC has been unable to locate any evidence that the remaining payments totaling \$3,000, which were reported on SAXPAC's originally-filed reports, were actually made to McGahn & Associates.⁴

¹ We believe that Ward's apparent theft from SAXPAC may constitute violations of other federal criminal provisions outside of the jurisdiction of the Federal Election Commission, and we have begun in communication with the appropriate law enforcement authorities to address these concerns.

⁴ These two payments to McGahn & Associates are eliminated in the amended October 20 and November 20, 2007, reports.

The January 2008 FEC report discloses \$130.55 in miscellaneous expenditures for which SAXPAC can find no accompanying withdrawal from the bank account.

The January 2008 report also omitted a \$1,000 deposit made on January 9, 2008. Upon review, this deposit was a check written from the "Leading Us In Success" PAC, which is Representative Luis Fortuno's Leadership PAC. The amended February 20, 2008, report reflects the source of these funds.

The amended reports for October 20, 2007, November 20, 2007, December 20, 2007, January 31, 2008, and February 20, 2008, have also been amended to reflect bank charges of \$12 per month that were not reported in prior FEC filings. The amended reports reflect the actual activity in the bank account for those months.

SAXPAC identified an additional discrepancy of \$1,000 in which a contribution was initially believed to have been deposited into SAXPAC's bank account, but the FEC reporting software apparently did not include the receipt in the respective Schedule A receipt subtotal because it was designated a memo item. As a result, the June 20, 2006, report was amended. Upon further review, however, additional explanation is required. The originally filed report, Schedule A, page 9 of 13, Entry C, discloses a \$1,000 contribution from Dannie J. O'Brien that was originally reported as a memo item. In fact, this check was never deposited into SAXPAC's bank account, and the committee has no records in its possession indicating that O'Brien ever made a contribution to SAXPAC.

We believe Ward's failure to accurately file the above mentioned original reports was in knowing and willful violation of 2 U.S.C. §§ 434(b) and 11 C.F.R. § 104.3.

New Post-Termination Reports

Upon learning from news reports about the NRCC's concerns with Chris Ward, SAXPAC contacted its bank and learned of post-FEC termination activity in its bank account. To comply with the FECA, SAXPAC has filed new monthly reports (March 20 and April 20, 2008) reflecting unauthorized activity in its bank account in February and March 2008.

March 20, 2008 Report

The amended report filed for March 20, 2008, discloses a cash deposit of \$2,393.45 on February 6, 2008. This deposit was made by Chris Ward in apparent violation of 11 C.F.R. 110.4(c). SAXPAC has been unable to identify the source of the cash used for this deposit.

On February 29, 2008, a \$3,000 issued to McGahn & Associates was cashed. It appears that this check was dated January 25, 2008 and reported on the January 2008

month report. The \$3,000 check did not clear when it was negotiated on February 29, 2008. Because the account did not have sufficient funds to clear the check, the bank assessed a \$35 overdraft fee.⁵

April 20, 2008 Report

The new April 20, 2008, report shows the negative balance at the start of the month, a \$12 fee assessed by the bank, and the receipt of cash from Congressman Jim Saxton in the amount of \$59.01. Congressman Saxton's funds returned the account balance to zero, after which the account was closed.

Conclusion

We believe that these actions by Ward constitute knowing and willful violations of the FECA, and respectfully request that the Commission investigate and take appropriate action to address these multiple violations by Ward.

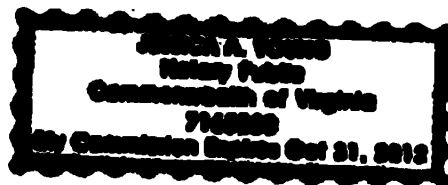


