Re: Complaint of possible federal election law violation(s)

MUR # 6192

Please find enclosed three exhibits that pertain to 2008 campaign finance disclosures of the *Madison County (Illinois) Democrat Central Committee (MCDCC)*. These disclosures were made to the *Illinois Board of Elections (IBOE)* as required by state law:

1. IBOE Form D-2, Report of Campaign Contributions and Expenditures: Semiannual Report, for the reporting period 1 January 2008 through 30 June 2008.
2. IBOE Form D-2 for the reporting period 1 July 2008 through 31 December 2008.
3. Names and addresses of the MCDCC and its Chairman and Treasurer.

A search of the FEC website did not return reference to FEC registration of the MCDCC as required of local party committees exceeding certain statutory financial thresholds.

Page 15 of Exhibit 2. lists a transfer out from the MCDCC in the amount of \$1,000.00 to the *Friends of Daniel Davis* committee. Mr. Davis was the 2008 Democrat candidate for the US House of Representatives, Illinois 19th District. Mr. Davis's committee apparently reported the contribution to the FEC.

With respect to the 2008 general election and previous elections, the MCDCC has paid for and directed creation and dissemination of campaign literature, mailings, media advertisements and web pages, as well as rallies, fundraisers and voting promotion of both federal and non-federal candidates. Exhibits 1. and 2. reflect the MCDECC's 2008 expenditures for those activities. They seem to have exceeded \$5,000 in one year.

I do not know if the MCDCC has kept separate accounts of its federal and non-federal contributions and expenditures, but apparently the MCDCC has not reported what may be federally governed activities to the FEC.

Page 6 of Exhibit 2. Lists among others what are called "individual contributions" to the MCDCC from the SimmonsCooper Law Firm of East Alton, IL totaling \$50,800.00. This obviously exceeds the \$10,000 federal limit on individual contributions to local party committees. Moreover, SimmonsCooper is a limited liability corporation which may be prohibited from donating to federal candidates.

Pages 7 and 14 of Exhibit 2. lists contributions by the Lakin Law Firm of Wood River, IL totaling \$10,594.04. The Lakin Law Firm is also an LLC.

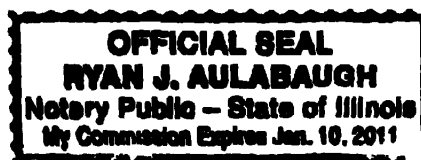

The exhibits detail contributions by many other corporations and labor unions to the MCDCC.
