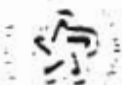

GENERAL COUNSEL'S REPORT

Background

On June 12, 1978, the Disclosure Division referred to the Office of General Counsel the Kentucky candidates and committees which were published on May 20, 1978 as 10 Day Pre Primary Report non-filers. These reports were due on May 13, 1978. Reason to believe notices were sent on May 15, 1978 and reasonable cause to believe notices were sent on May 17, 1978. None of the candidates won the election.

Evidence

Philip Baker filed his 10 Day Pre Primary Report on May 22, 1978 which showed aggregate receipts and expenditures totalling \$1615; however, no reports have been filed by the Baker for Congress Committee. Mr. Baker received 3.4% of the votes.

Neither Thurman Hamlin nor his campaign committee filed a 10 Day Pre-Primary Report. Mr. Hamlin did send in a letter in March which stated that he had not received any contributions nor had he made any expenditures. Mr. Hamlin received the reason to believe and reasonable cause to believe notices for both himself and his committee. Mr. Thurman Hamlin received 21.7% of the vote.

The William Taylor for U.S. Senate Committee filed on May 15, 1978 before publication. The aggregate receipts and expenditures totalled \$1314. The candidate filed his report on May 22, 1978 which showed no receipts or expenditures. Mr. Taylor received 7.4% of the vote.

George Tolhurst waived reporting on April 24, 1978. His committee filed the 10 Day Pre-Primary Report on May 24, 1978. The aggregate receipts and expenditures together equaled \$23. 5.9% of the vote went to Mr. Tolhurst.

Jack Watson, who received 11.2% of the vote, filed his report on May 16, 1978. On May 22, 1978, his campaign committee filed its reports. Mr. Watson received and expended \$10,250. His committee received no contributions nor did it make any expenditures.

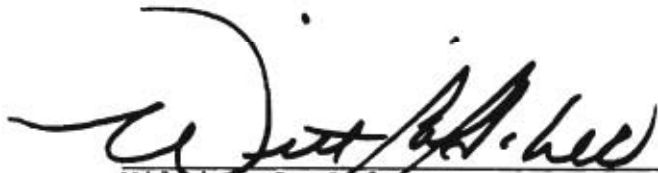
Analysis

None of the candidates had aggregate receipts or expenditures totaling more than \$25,000. Also, none of the candidates received 30% of the vote.

Recommendation

It is recommended that no further action be taken at this time against Philip Baker, Thurman Hamlin, William Taylor, George Tolhurst, Jack Watson or their committees.

After making many phone calls I was able to determine that Mr Hamlin does not have a phone. On a previous call he made to me, he told me that he lived in a motel and gave me a phone number. Both the motel and the phone number appear to be non-existent. I called London Ky to see if I could get a cross reference on his address and match it with a motel (or anything similar). The person who answered the phone at city hall said that as far as she knew, there was no motel, boarding house or anything else at the address listed on the form 2, however this person said that she knew Mr. Hamlin quite well. It appears that Mr. Hamlin is somewhat of a town "fixture". The person who was giving me this information said that she would be putting it nicely if she said that Mr Hamlin was "not quite right". She said that he walks the streets constantly and verblly harasses any one who has the patience to listen to his ramblings. She indicate to me that although Mr. Hamlin spends a lot of time walking around, he has not been seen in the last few weeks. She suggested that I call the Sheriff's department and let them know that I wanted to talk to him.

FROM: Chip Foley to the Sheriff's Office of London KY

I called the Sheriff's Office and talked to the receptionist. The Sheriff and all the Deputies were out. I told her that I was calling from the FEC and that I had been referred to the Sheriff's office by City Hall. I told her that I needed to get in verbal contact with Mr. Hamlin to complete some business between himself and the FEC. This person also gave me the same story that I got from city hall indicating that Mr. Hamlin is well known in London for his strange and unperdictable ways. I gave her the toll free number and asked her if she would have the Sheriff or one of the Deputies give me a call. She said that she would give my number to the Sheriff's staff and they in turn would give it to Mr. Hamlin in their travels with the instruction to call the FEC as soon as possible.

RESPONSIBILITIES UNDER 2 U.S.C. 436(b)(1)

This will acknowledge receipt of your Statement of Candidate Received 4/24/78. In that statement, you have indicated that your principal campaign committee and other authorized committees will be receiving and disbursing all funds in support of your candidacy in the 1978 election(s). Therefore, based upon this certification, your waiver of your reporting responsibility as a candidate is confirmed.

Section 101.3 of the Federal Election Commission Regulations states that such a waiver shall continue in effect as long as the candidate complies with the conditions under which it was granted. Those conditions are as follows:

1. Within 5 days after personally receiving a contribution, the candidate will surrender possession of the entire contribution to the treasurer of his or her principal campaign committee without expending any of the proceeds thereof. No contributions shall be commingled with the candidate's personal funds or accounts. Contributions conveyed by check, money order, or other written instruments shall be consigned directly to the political committee and shall not be cashed or redeemed by the candidate.
2. The candidate shall not make any unreimbursed expenditures for his or her campaign, except that this paragraph does not preclude a candidate from making an expenditure from personal funds to the candidate's designated principal campaign committee which shall be reported by the committee as a contribution received.

Breckinridge Becomes Third House Member Defeated; Sen. Huddleston Wins Easily

Rep. John B. Breckinridge May 23 became the third House member this year to be sidelined by a primary defeat.

He lost narrowly to state Sen. Tom Easterly for the Democratic nomination in the Kentucky 6th District, and joins Reps. Dale Milford, D-Texas, and Robert N. C. Nix, D-Pa., who had been beaten earlier this month by primary challengers. (*Kentucky outlook, Weekly Report p. 1187*)

Breckinridge's defeat stood out in what was generally a quiet primary. The six other House incumbents and U.S. Sen. Walter (Dee) Huddleston, D, all easily won renomination, while the Republican Senate nomination went to state Rep. Louie R. Guenther in a statewide race that attracted a turnout of barely 30,000.

Easterly's victory in the Democratic 6th was not totally unexpected. Breckinridge had taken his primary challenge casually, spending little money and campaigning in the district primarily on weekends. His complacent approach contrasted with the younger Easterly, who had pursued the nomination frenetically for nearly a year. He charged that Breckinridge was rarely visible in the district and was not fighting for the district's interests, charges the three-term incumbent repeatedly denied.

Returns:

Breckinridge Becomes Third House Member Defeated; Sen. Huddleston Wins Easily

Rep. John B. Breckinridge May 23 became the third House member this year to be sidelined by a primary defeat.

He lost narrowly to state Sen. Tom Easterly for the Democratic nomination in the Kentucky 6th District, and joins Reps. Dale Milford, D-Texas, and Robert N. C. Nix, D-Pa., who had been beaten earlier this month by primary challengers. (*Kentucky outlook, Weekly Report p. 1187*)

Breckinridge's defeat stood out in what was generally a quiet primary. The six other House incumbents and U.S. Sen. Walter (Dee) Huddleston, D, all easily won renomination, while the Republican Senate nomination went to state Rep. Louie R. Guenther in a statewide race that attracted a turnout of barely 30,000.

Easterly's victory in the Democratic 6th was not totally unexpected. Breckinridge had taken his primary challenge casually, spending little money and campaigning in the district primarily on weekends. His complacent approach contrasted with the younger Easterly, who had pursued the nomination frenetically for nearly a year. He charged that Breckinridge was rarely visible in the district and was not fighting for the district's interests, charges the three-term incumbent repeatedly denied.
