Re: John Callahan and John Callahan for Congress

Dear Ms. Duncan:

Pursuant to 2 USC § 437g(a)(1) and 11 CFR § 111.4, please accept this letter as a Complaint against John Callahan (Callahan) and John Callahan for Congress ("the Committee") for operating in violation of the Federal Election Campaign Act of 1971, as amended (the "Act"), and Federal Election Commission ("FEC" or "Commission") regulations and, more specifically, for violation of the prohibited transfer provision set forth in 11 CFR 110.3(d) and for violation of the testing the waters provisions set forth in 11 CFR 100.72(a) and 100.131(a).

**I. Facts**

John Callahan for Congress is the principal campaign committee for John Callahan, a candidate for the United States House of Representatives, campaigning to represent Pennsylvania's 15th Congressional District. The Committee's FEC Form 1 Statement of Organization was filed with the FEC on July 31, 2009. Callahan's FEC Form 2 Statement of Candidacy was also filed with the FEC on July 31, 2009.

Friends of John Callahan is registered with the Pennsylvania Department of State as a nonfederal political action committee. See Attachment 1. It has been reported that Friends of John Callahan is Callahan's mayoral campaign committee. See Attachment 2. Friends of John Callahan is not registered with the FEC.

An October 22, 2009, article in *The Morning Call*, stated "Callahan, before he even announced a run, hired a Democratic research firm to find out what criminal background checks the name John Callahan would dig up, according to campaign manager Justin Schall." See Attachment 3.

According to campaign finance reports filed with the Pennsylvania Department of State, Friends of John Callahan made two disbursements to Stamford Campaigns in Austin, TX, for "research." The first disbursement took place on May 6, 2009, in the amount of \$4,500. The second payment was made on June 22, 2009, in the amount of \$5,432.83.

See Attachment 4. It is important to note that John Callahan had not yet filed with the FEC at the time that these payments were made.

The Facebook profile for Stanford Campaigns states that it is "one of the leading Democratic opposition research companies in the country." See Attachment 5. A website listed on the same profile, [www.opprsearch.com](http://www.opprsearch.com), also touts the company's success in opposition research. See Attachment 6.

The FEC Form 3 for the Committee filed on October 15, 2009, reflects only two payments made prior to July 31, 2009. The purposes of these payments are listed as "domain registration" and "post office box." No contributions from Friends of John Callahan are reported on the same FEC Form 3, and no expenditures to Stanford Campaigns are reported.

## II. Relevant Law

The Act and FEC regulations define contribution to include "any gift, subscription, loan, advance, or deposit or money or anything of value made by any person for the purpose of influencing any election for Federal office." 2 USC 431(8)(A)(i), 11 CFR 100.52(a).

The regulations also state that an in-kind contribution is created when goods or services are offered for free or at less than the usual charge. An in-kind contribution is also created when a person pays for services on a committee's behalf. 11 CFR 100.52(d)(1) and 11 CFR 100.111(e)(1).

FEC regulations require the reporting of contributions from "all committees (including political committees and committees which do not qualify as political committees under the Act) which make contributions to the reporting committee during the reporting period." 11 CFR 104.3(a)(4)(ii).

Commission regulations state that a candidate's authorized committee for one office receiving a transfer from that same candidate's authorized committee for another office must report the total transfer. 11 CFR 104.3(a)(4)(iii)(A). However, the regulations state that "transfers of funds or assets from a candidate's campaign committee or account for a nonfederal election to his or her principal campaign committee or other authorized committee for a federal election are prohibited." 11 CFR 110.3(d).

The regulations permit an individual who has not decided to run for office to raise funds to "test the waters" and explore whether or not an individual should become a candidate. 11 CFR § 100.72, 11 CFR § 100.131. The individual is required to keep records of all of

these payments and, if the individual subsequently becomes a candidate, money raised and spent to test the waters are considered contributions and expenditures under the Act and must be reported by the campaign. 11 CFR § 101.3.

### III. Legal Analysis

On May 6 and June 22, 2009, the Committee violated FEC regulations when it allowed Friends of John Callahan to make an in-kind contribution to John Callahan for Congress.

Callahan's own campaign manager, Justin Schall, stated that payments were made for opposition research in preparation for Callahan's run for congress. Yet, the Committee reported no payments for research prior to July 31, 2009, the date Callahan filed the FEC Form 2 Statement of Candidacy. Friends of John Callahan, however, reported a total of \$9,932.83 in payments for research prior to July 31, 2009.

Payments made for services on the Committee's behalf by Friends of John Callahan create an in-kind contribution to the Committee. Friends of John Callahan is Callahan's campaign committee for a nonfederal election. John Callahan for Congress is the principal campaign committee for a federal election. Commission regulations plainly prohibit transfers of funds or assets between a candidate's committee for a nonfederal election to a candidate's principal campaign committee.

In addition to accepting an illegal contribution, the Committee also failed to report the illegal transfer as a contribution. Commission regulations allowed Callahan to receive contributions and make expenditures to determine whether or not he should run for congress. The statements by Callahan's campaign manager show that Callahan hired an opposition researcher to see what the researcher could "dig up" on Callahan prior to running for congress. Certainly the results of this research were used in determining whether or not Callahan should become a candidate. Once Callahan determined that he was running for congress he was required to report those contributions and expenditures. Yet, even after Callahan declared his candidacy, the Committee reported no contribution from Friends of John Callahan or any expenditures to Stanford Campaigns.

Acceptance of an in-kind contribution from Friends of John Callahan by the Committee is a transfer from Callahan's nonfederal campaign committee to his principal campaign committee. This constitutes an illegal transfer under FEC regulations. Furthermore, the Committee failed to report this contribution as required under the testing the waters provision.



IV. Conclusion

Upon information and belief, and based upon the facts relayed herein, John Callahan and John Callahan for Congress have violated the Federal Election Campaign Act of 1971, as amended, and Federal Election Commission Regulations. Accordingly, we respectfully request that the Commission conduct an immediate investigation into the violations outlined above and impose the maximum penalty under law.

The foregoing is correct and accurate to the best of my knowledge, information and belief.

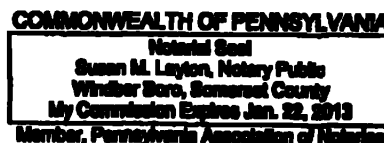

## Mayor's primary bets paid little dividend

Campaign report shows he gave \$14,000 to 9 Democratic candidates

Mayor John Cafarella's campaign committee dumped more than \$14,000 behind five Democratic Baltimore City Council candidates, only one of whom won a seat in last month's primary election, according to campaign finance reports filed Thursday.

Friends of John Cafarella, according to the reports, gave \$4,700 each to Dawn Sanders, Dawn Harshbarger and Neena Dehn. Three of the 10 Democrats who battled for four spots in the May 17 primary.

Only Dehn won.

While Cafarella's support of the three candidates comes as no surprise, the extent of his financial involvement in their campaigns was revealed for the first time with Thursday's campaign finance filing deadline.

In addition to his support for Sanders, Dehn and Harshbarger, Cafarella said out earlier before the election using voters' right to vote for Democratic incumbents Joan Schall and Joseph F. Looney Jr.

Schall, Looney and fellow incumbent Democrat Michael Schneider, all of whom won Democratic nominations, said last month that they thought the mayor's intervention in the race was wrong. None of the three would be reelected for term on Thursday.

Cafarella said in the history that he participated in the three candidates' campaigns because he thought they "would be open-minded and make decisions for the greater good of the city."

Overall, the 10 Democratic council candidates spent nearly \$122,000 on their campaigns, with Schneider leading the way spending more than \$44,000, according to the campaign finance reports.

But money, it appears, didn't decide the election.

Only two of the top 10 campaign spenders -- Schneider and Dehn -- captured nominations.

Dehn spent \$14,000 on her campaign.

Looney, who spent \$10,000 between Jan. 1 and June 6, was only fifth on the list of top spenders, yet finished with the third highest vote total.

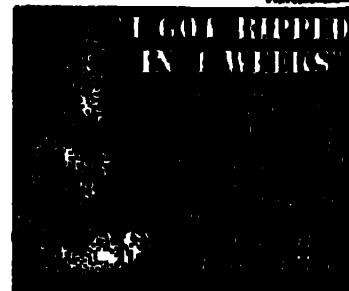
Schall, outspent only two other candidates, with \$6,000.

Schneider nearly tripled the next highest spender. Some of that, however, was spent on a New York City polling company to determine whether he wanted to run for mayor against Cafarella.

In the end, he decided against such a move, making his one of the most expensive City Council campaigns ever in Baltimore.

Schneider, who finished second to Schneider in expenses, with \$10,100, said he doesn't regret his expensive run for a council seat.

"To run an effective campaign it costs money," said Sanders, who finished eighth out of the 10 Democrats.



candidate: "My idea is that if you invested in Dave Gordon, I'm going to spend on Dave Gordon. We wanted to spend everything."

His report detailed only \$150 left over.

Hendrich spent the \$112,000, ending campaign and finished with the 11th-highest vote total.

Campaign expenses for the four other Democratic candidates were \$8,897 by incumbent James Aronow; \$9,084 by William Finkbeiner; \$4,884 by Richard Gendron; and \$2,100 by Michelle Lerner.

Two Republicans faced no opposition in the primary and will be on the November ballot, James Faltowski spent \$400 and Miller Lee spent \$201.

Dems. GOP digging to find out as much as they can about Dent, Callahan

The day after Bethlehem Mayor John Callahan announced his bid for Congress in July, the Republicans' national campaign arm requested 18 public records ranging from his City Council voting and attendance records to travel expenses. Another GOP consultant requested his phone logs, government e-mails and salary information.

Callahan's opponent, U.S. Rep. Charlie Dent, said he's been notified by the General Assembly in Harrisburg that Democrats are after information about his office spending during 14 years in the state House and Senate.

With the election for the 18th Congressional District seat a year away, hired political guns are far into the ammunition-gathering stage of the contest, jockeying for inside even before Dent, a Republican, and Callahan, the only Democrat to announce a challenge, have won their respective primaries or hit the campaign trail in earnest.

While the candidates are wooing donors at high-dollar fundraisers, opposition researchers are looking for skeletons in closets — the kind of stuff that can wind up in attack ads or mailers.

The right-to-know requests filed by the opposing camps, obtained by The Morning Call, offer an insider's look at the underbelly of congressional campaigns in their earliest stages. The requests from both sides reveal the fishing expeditions for information, far-reaching possible narratives for the campaigns and put the candidates on notice that it will be a hard-fought contest to represent the greater Lehigh Valley in Congress.

"They're laying the groundwork for their strategy for the campaign. They're looking for any possible piece of evidence or material that can help build a case against their opponent," said Christopher Borick, political science professor at Muhlenberg College in Allentown.

The candidates aren't just focused on their opponents. Callahan, before he even announced a run, hired a Democratic research firm to find out what criminal background checks the name John Callahan would dig up, according to campaign manager Judith Schell. It was also curious to know what a check of contractors who had done business with the city would reveal, the requests show.

The guns find out what an opponent might

information doesn't always come in equal doses. The Freedom of Information Act doesn't apply to Congress, meaning logs of meetings and phone calls for Dent are unavailable. Congressional members make public their office expenses.

What Callahan has at his fingertips is Dent's voting history since he arrived in Congress in 2005.

A spokesman for the Democratic Congressional Campaign Committee said it doesn't discuss opposition research.

The oddity, in Callahan's case, is that City Hall employees, by responding to information requests, are essentially doing legwork for their boss' political foe.

Callahan shrugged off the irony, saying "It's the law." But Callahan questioned how the information requested will help voters make an informed decision.

"I hope that this campaign will be based on issues that are important to everyday people," Callahan said. "Some of these right-to-know requests don't necessarily seem to get to issues that matter to everyday people."

Once Callahan announced his bid, the National Republican Congressional Committee sent formal requests on

letterhead. It wanted to peruse letters written by Callahan and City Council regarding state and federal funding requests, travel expenses, city budget and any financial disclosure forms Callahan may have submitted.

A GOP consultant from New Jersey requested Callahan's pension, benefit and salary information. He wants copies of all expenses and copies of the minutes when Callahan was chairman of council's Finance and Public Works committees.

Going back to 1997, the consultant wants the history of city vehicles: maintenance costs, gasoline costs, purchases, total number of vehicles as well as their make and model. He wants to know the cell phones issued to city employees and animal units.

National Republican Congressional Committee spokesman Tony Mazzola said the requests "are routine and common checks" designed to ensure voters have a clear picture of the two candidates.

"It is important to look through these records and find out how resources are being used," Mazzola said.

Bethlehem assistant solicitor Joseph Kelly said the office is working on fulfilling the requests. He described the amount of information requested as "massive." Records show as of the end of August, the city charged \$185.22 for copies and postage related to those gathering information on Callahan.

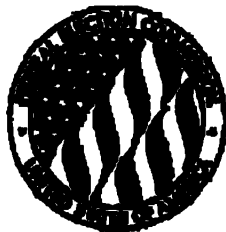
