Enclosed please find a signed Statement of Designation of Counsel form authorizing me to act as counsel for Alan Grayson in the above-entitled action.

The complaint in MUR 6268 was received by the respondent on April 12, 2010. As you know, 11 C.F.R. § 111.6(a) provides that a respondent may file a written response to a complaint within fifteen (15) days of receiving it. Since the complaint was served on April 12, 2010, a response is due on Tuesday, April 27, 2010.

Although I have initiated an investigation into the allegations made in the complaint, there will not be sufficient time to complete that effort and file a written response by April 27, 2010. In order to prepare a complete response, I will need to interview a number of current and former employees or volunteers with the Committee to Elect Alan Grayson and Maddox for Commissioner of Agriculture & Consumer Services who have direct knowledge of the events alleged to have occurred in the complaint. It may take a significant amount of time to first locate and then interview all these individuals.
