Since the majority of the above-named respondents received the complaint on March 19, 2010, responses are due next Tuesday, May 4, 2010.

Although I have initiated an investigation into the numerous allegations of the complaint, there will not be sufficient time to complete that effort and file written responses for all six of the above-named respondents by next Tuesday. In order to prepare a complete response for each of the respondents, I will need to interview each of them as well as other witnesses who may have direct knowledge of the events alleged to have occurred in the complaint. Accordingly, I hereby request an extension of time of thirty (30) days until Thursday, June 3, 2010 in order to file responses to the complaint in MUR 6270 on behalf of each the above-named respondents.

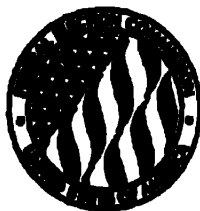
